#### LANE COUNTY BUDGET COMMITTEE MEETING Thursday, May 3, 2018 2:00 p.m. Board of County Commissioner's Conference Room

Chair Hijmans asks a question regarding reduction of fatal accidents. Mr. Dingle mentions a new team which has been formed, Fatal Crash Investigation, with Becky Taylor. Looking into creating a rural version of Uber/Lyft, among other things.

Mr. Vloedman asks about how much time is spent on security v. audits. Mr. Finch describes the process of performing an audit on data security, and the future goals of which divisions are in charge of these audits.

Mr. Abel inquires regarding decreases in expenses for Materials & Services (pg 300-301), specifically with Radios and reimbursable expenses. Mr. Finch says he will research that question and get back with him about Radios. Jessie Hollingsworth answers the question about reimbursable expenses stating that the account line they were using was simply the wrong account line and so it was shifted into another line item that was more accurate.

Mr. Carrasco asks about equity and access, and whether or not we are aligning needs. Mr. Finch responds that we are aligned with the strategic plan for Lane County. Mr. Carrasco asks for information regarding what changes have been made to make websites more accessible for mobile phone users. Mr. Finch explains what changes have been made to improve this type of access.

Commissioner Leiken asks if we would lose contact in the case of an emergency if the grid went down. Mr. Harmon answers that we would not lose contact, we have back-up generators to prevent this from happening.

Commissioner Leiken asks if the strong economy has created a challenge in finding adequate "talent" recruitment. Mr. Finch answers that they are having good luck recruiting entry level positions, however some of the senior level positions can be harder to fill.

Chair Hijmans asks if voter fraud falls under the Technology Services Dept. Mr. Finch responds that it does not, ballot machines are not connected to the internet.

Jessie Hollingsworth, Kay Youngblood, and Kim Morgan also participated in the conversation and question answering.

Commissioner Farr asks about Behavioral Health staff positions not being filled. Ms. Holmes answers that overall recruitment has been challenging for a variety of reasons, and they are looking at implementing a variety of changes.

Mr. Abel asks how long Ms. Holmes has been in this position, and she responds that it has been five months. He goes on to ask for clarification regarding the UO PPPM Program. She responds that it is helpful for a number of reasons, mainly perspective.

Mr. Carrasco asks about the goals with employee healthcare. Ms. Wood responds that the are having an increase of employees that visits to the Live Well Clinic, and that word of mouth is a big factor.

Chair Hijmans makes a statement about the upcoming audits, suggesting the association of the PPPM review with the final audit. Ms. Holmes answers that she been connecting those treads within the department.
