**COUNTY CONDOMINIUM - \$2,250 + \$30 PER BUILDING + \$100 SURVEY FILING FEE**

**AFFIDAVIT OF CORRECTION - \$50 + DEEDS & RECORDS RECORDING FEE**

**POST MONUMENTATION AFFIDAVIT - \$50 + DEEDS & RECORDS RECORDING FEE**

**PLAT REESTABLISHMENT AFFIDAVIT - \$50 + DEEDS & RECORDS RECORDING FEE**

**VACATIONS - \$4,800 Processing Fee Deposit for vacation with a public hearing; \$3,400 Processing Fee Deposit for vacation without a public hearing. Final fee is based on actual costs incurred. The difference between actual costs and deposit will be billed or refunded to the applicant. Final vacation documents will not be recorded until all fees due are paid in full.**

## **MISCELLANEOUS**

**NONCOMPLYING LAND SURVEY** - \$10 for copying and mailing a land survey map and notifying the Board of Engineering Examiners of an apparent noncomplying land survey.

**DISTURBED GOVERNMENT CORNER** - For servicing government corners disturbed by any person or public agency in accordance with ORS 209.140 or 209.150, the Lane County Surveyor may recover the cost of crew wages and vehicle usage to reimburse County for lowering and replacement of government corner monuments or corner accessories.

The cost of crew and vehicle usage to lower and service the corner or its accessories shall be paid by agency causing the corner to be disturbed to Lane County Surveyor within 10 days of receipt of the invoice for work performed.
