DB New Dangerous Behavior, new formal complaints processed/citation issued

Voucher Approved and processed, not necessarily used
Voucher Used, submitted for payment to LCAS (from Vet)

Impounds Includes DOA's (dead on arrival)

PR Public relations. An informal request for contact to 'talk' to a citizen about an issue. Complainant doesn't want a ticket issued.
