- Ed Alverson will provide an update on the BLM fuels reductions grant and current projects.
- Mike Allen will give an update on the Climate Advisory Committee Report.
- Stewart Covered Bridge update, Ranger Bowen followed up with homeowner Trevor Lockward regarding the possibility of putting in a fence, but area is in a County Road right-of-way. Bowen is checking in with the Roads Division.
- Henry will provide an update on the Harbor Vista cabins and look in to a field trip. Henry stated the cabins are almost completed.

 Approved with one correction; Mike Allen motioned, Carl Stiefbold seconded, motion passed unanimously.

00:09:00 New Business

- Facility Condition Assessment Phase Two Report
 Dean Leonard from Faithful and Gould presented the Facilities Condition Assessment phase
 two report. An additional thirteen parks were assessed in the second phase. The results
 from the Facility Condition Index ratings indicated that one park (Triangle Lake Park) was
 rated in good condition, ten parks (Archie Knowles, Bender Landing, Howard Buford, Camp
 Lane, Farnham, Hendricks Bridge, Linslaw, Perkins Peninsula, Westlake, and Zumwalt) were
 rated as in poor condition, and two parks (Harbor Vista and North Jetty) were rated as in
 very poor condition. The total deferred maintenance over the study period is \$8,001,090;
 however, if there are no capital investments made toward the deficiencies, the costs will
 grow to an estimated \$11,314,492 over the next ten years.
- BLM Fuels Reduction Status
 Ed Alverson gave a PowerPoint presentation on Fuels Reduction Funding from the Bureau of Land Management. The Lane County Community Wildfire Protection Plan has actions identified and one is related to hazardous fuels in landscape. The Parks Division was awarded \$150,000 from BLM for fuels reduction in fiscal year 2022.

- Armitage Campground Expansion

The Open House is scheduled on April 12, 2022 in the Goodson Room at 6:00pm. A press release was distributed and the project is listed in more detail on the Lane County Parks website. The meeting will be chance for the public to provide feedback on the preliminary engineering design.

District 5 Parks Advisory Committee Vacancy

The applicant withdrew their application. Henry received a recommendation for Bob Wilson and is waiting to hear back from him. Henry asked the PAC to assist with recruiting.

00:59:05 Staff Updates/Reports

- American Recovery Plan Act
 Lane County Public Works was awarded \$4.27 million in funding for water and sewer infrastructure at Orchard Point, Richardson, Armitage, and Baker Bay.
- Fern Ridge Water Storage Tanks
 Four tanks will be added to the water system to double the storage capacity at Richardson and Orchard Point parks. Hopefully the tanks will be installed prior to the end of the summer once the environmental and cultural permitting is received from the Army Corps of Engineers.
- Local Option Levy
 - The Phase Two Facilities Condition Assessment report will go to the board on April 26, 2022. The Parks Division identified funding to hire a public poling consultant to distribute a survey to likely voters in May. The Division will hire a public information consultant to assist with marketing materials and public messaging. Stakeholder meetings in the four regions of the county will begin in May as well.
- Climate Advisory Committee Report
 Mike Allen gave an update on the efforts of the Climate Advisory Committee. The updated second phase plan will go back to the Board of Commissioners on April 12, 2022. The third phase of the plan will deal with resilience.
















DESIGN PLAN FOR RV EXPANSION








ARMITAGE PARK CAMPGROUND EXPANSION





December 2021 – January 2022

- January 10, 2022 Parks Advisory Committee (PAC)
 - Present implementation calendar and work plan. Receive feedback and revise as necessary.
- Evaluate and Prioritize Phase 1 Deferred Maintenance Projects and FY 23-27 Capital Improvement Plan approved by PAC and BCC
 - o Develop Priority Matrix (example categories listed below)
 - Project need based on impacts to functionality of the park, site, or facility. Consider risk of failure.
 - Safety impacts to park visitors and/or staff
 - Available Funding Sources Existing Park Division funds, SDC's, County discretionary funds (e.g., general funds, ARPA, video lottery, etc.), county road funds, grant funds, revenue bonds, etc.
 - Funding Capacity Is the project within the funding capacity of the parks division with or without other resources? Can the project be phased?
 - Ongoing Costs Consider costs of ongoing maintenance

March 2022

April 2022

Lane County Parks Natural Areas Operations Report for April 2022 - Ed Alverson

- -A big task this month (and team effort) was preparing and submitting an application to BLM for an Assistance Agreement to provide funding for fuels reduction/management in eight Lane County Parks. If approved this agreement would become effective after our current agreement expires in June of 2023. The funding request was for \$1 million.
- -I facilitated a number of HBRA stakeholder meetings, including meetings to discuss the HBRA 50th Anniversary, and to discuss messaging of dog leash rules in HBRA
- -I did photomonitoring in HBRA in the Swing Hill and Spring Box management units where fuels management work is being done.
- -I participated in a stakeholder interview as part of the Marine Board grant to do planning and permitting for a future canoe and kayak put-in facility at HBRA.
- -I met a team of Oregon Dept. of Agriculture staff out at HBRA to help get them started on monitoring of the Bradshaw's lomatium population. The species has been de-listed at the federal level but is still listed as endangered by the State of Oregon.
- -I issued processed Special Use Permits, including one for an artist to harvest invasive giant knotweed shoots to use to make paper for an art project, and another to record songbird songs at HBRA.
- -I worked with Bjorn set up and coordinate a contract with Trout Mountain Forestry to sell logs from trees removed as hazard trees from a county-owned parcel along Goodpasture Road in the Holiday Farm Fire area.
- -I provided four western redcedar saplings to plant in Harbor Vista Park for screening next to the new cabins
- -I helped staff the Open House for the Armitage Park Campground expansion project on April 12th.
- -I marked patches in Zumwalt Park to avoid mowing during the spring while the camas and other native wildflowers are blooming and setting seed.
- -I toured Hileman Park to check on habitat conditions and look for camp sites.
- -I participated in a meeting of the Rivers to Ridges Prescribed Burning subcommittee, in preparation for the upcoming prescribed burn season.
