| <b>Admin</b>         | Deliver or pick-up supplies, equip, veh maint, paperwork, DB enclosure inspects, etc.   |
| <b>Dispatch</b>      | Citizen complaint, request for service  |
| <b>AWO Int</b>       | Animal Welfare Officer initiated the call. ex: while on general patrol, picked-up a loose dog or he was flagged/contacted by a citizen while in the field |
| <b>Contact</b>       | Contact with someone in person (citizen, dog owner, complainant, Vet)   |
| <b>Citations</b>     | Issued - there may be more than one violation on each cite - stats are counted for each violation   |
| <b>License New</b>   | Mailed out letters advising dog owners we have received their dogs rabies record & they need to purchase a license  |
| <b>License Renew</b> | Mailed out letters advising dog owners their existing license and/or rabies is expired, or will expire within 30 days                                     |
| <b>RTO</b>           | Return to owner Ex: picked-up a dog running loose and returned home to owner without having to impound  |
| <b>Bites</b>         | Code required report of a bite resulting in skin breakage. Some may include a dispatch call for a Dangerous Behavior complaint.                           |
| <b>DB New</b>        | Dangerous Behavior, new formal complaints processed/citation issued   |
| <b>Voucher</b>       | Approved and processed, not necessarily used  |
| <b>Voucher</b>       | Used, submitted for payment to LCAS (from Vet)  |
| <b>Impounds</b>      | Includes DOA's (dead on arrival)  |
| <b>PR</b>            | Public relations. An informal request for contact to 'talk' to a citizen about an issue. Complainant doesn't want a ticket issued.                        |
