**Important Information:** Licensed facility fees are due each year on December 31<sup>st</sup>. Late payment penalty fees may be assessed at a rate of one-half the cost of the licensing fee. Late payment penalty fees are assessed every month, on the first day of the month, until the facility is closed, or the license is paid.
