WHEREAS Lane County acquired through property tax foreclosure in September, 2010 real property identified as Assessor's map no. 17-02-31-31-06704 and more particular described in attached Exhibit 1; and

WHEREAS the real property is encumbered with Federal tax liens from the Internal Revenue Service as well as local improvement liens from the City of Springfield; and

WHEREAS pursuant to Order 11-10-26-1 the Board authorized distributing sale proceeds from the real property equally between the County, City of Springfield and the Internal Revenue Service; and

WHEREAS the real property was offered at a Sheriff's sale on September 24, 2012, with a minimum bid of \$62,000 and remained unsold at the close of sale with no bids received.

NOW, THEREFORE, the Board of County Commissioners of Lane County ORDERS as follows:

- 1. That the above described real property be sold to David N. Hyland and Dave R. Hyland for \$30,000.
- 2. That the Board Chair is authorized to execute the Quitclaim Deed.
- 3. That the Property Management Officer is authorized to execute closing documents.
- 4. That the net proceeds be disbursed equally between Lane County, the City of Springfield and the Internal Revenue Service per Order 11-10-26-1.
- 5. That the County's share of sale proceeds be disbursed to fund 266-3632270-446120.
- 6. That this Order be entered into the records of the Board of Commissioners of the County.
