IN THE MATTER OF APPROVING CONTRACT EXTENSIONS THROUGH DECEMBER 31, 2013 FOR SERVICES FUNDED BY THE FINANCIAL ASSISTANCE AGREEMENT IN THE DEPARTMENT OF HEALTH & HUMAN SERVICES

WHEREAS, State of Oregon, Oregon Health Authority/Addictions and Mental Health Division requires Local Mental Health Authorities to provide mental health and addiction services; and

WHEREAS, Lane County provides many of these services through subcontracts with provider agencies; and

WHEREAS, the majority of contracts funded by The State of Oregon, Oregon Health Authority/Addictions and Mental Health Division are set to expire June 30, 2013; and

WHEREAS, the State has modified the process for allocating funds for services beginning July 1, 2013; and

WHEREAS, Lane County allocations have not been finalized as of this date which results in staff being unable to engage in the competitive selection processes necessary to contract with local mental health and addiction service providers; and

WHEREAS, extending current contracts through December 31, 2013 will allow staff to engage in competitive selection and execute services contracts for the remainder of the biennium once allocations are received from the State;

NOW, THEREFORE, the Board of County Commissioners of Lane County ORDERS as follows:

- 1. that the contracts listed in Appendix A be extended through December 31, 2013.
- 2. that the County Administrator be delegated to sign contract amendments as listed in Exhibit A
