**WHEREAS**, all of the projects and services covered by the contracts listed below are routine to the implementation of current County programs and services or have been previously discussed or approved by the Board; and


**WHEREAS**, these contracts and amendments exceed the County Administrator's authority to execute per LM21.145-147,
