3. That the proceeds be disbursed through the tax foreclosure fund.

**EXHIBIT "A"**

**LEGAL DESCRIPTION**

**18-05-17-00-00301**

Beginning at the iron pipe marking the N  $\frac{1}{4}$  corner of Section 27, Township 16 South, Range 4 East of the Willamette Meridian; thence East 636.50 feet and South 129.31 feet to an iron pin set on the Northerly line of the right of way of the relocated McKenzie Hwy.; thence Southwesterly following the Northerly right of way of said Hwy., 437.13 feet; thence Northwesterly at right angles to said Hwy., 20.0 feet; thence Northeasterly parallel with and 20 feet Northerly of said Hwy. 189.13 feet to the TRUE POINT OF BEGINNING; thence Northeasterly parallel with and 20 feet Northerly of said Hwy. 48.0 feet; thence Northwesterly 440 feet, mor or less, to a point on the Northerly line of a tract of land described in a Memo of contract executed by Walter R Graham, et ux, which was recorded 12/13/74, under Recorder's Reception No. 74-52560, Lane County Oregon Deed Records, as Exhibit 3, said point is also 200 feet S 58\* 01' 51" West from the most Northeast corner of said teract of land; thence Southeasterly in a straight line to the true point of beginning.
