

BEFORE THE BOARD OF COMMISSIONERS OF LANE COUNTY, OREGON

ORDER NO: 14-05-20-04

IN THE MATTER OF AWARDED A MULTI-YEAR CONTRACT TO MOTOROLA SOLUTIONS, INC. IN THE AMOUNT OF \$ 6,420,139 TO UPGRADE AND MAINTAIN THE EMERGENCY COMMUNICATIONS SYSTEMS OPERATED BY THE LANE RADIO INTEROPERABILITY GROUP (LRIG) AND THE 7-COUNTY REGIONAL INTEROPERABLE RADIO SYSTEM (SW7), AND TO AUTHORIZE THE LANE COUNTY ADMINISTRATOR TO EXECUTE THE CONTRACT, REVISED LRIG AGREEMENT, AND THE SUPPORTING AGREEMENTS WITH THE LRIG AND SW7 PARTIES.

WHEREAS, the Board of Commissioners approved the Intergovernmental Agreement establishing the 7-County Regional Interoperable Radio System with the Counties of Benton, Coos, Curry, Douglas, Josephine, Lane, and Linn on May 11, 2010; and

WHEREAS, the Board of Commissioners approved the Intergovernmental Agreement establishing the Lane Regional Interoperability Group with the City of Eugene, City of Springfield, and Eugene Water & Electric Board on May 11, 2010; and

WHEREAS, the radio systems established in these Agreements are essential to the continued functionality of the agencies and their ability to communicate both daily and in emergencies; and

WHEREAS, the continued functionality of these essential systems over both the short- and long-term is dependent upon upgrading and maintenance of the communication systems; and

WHEREAS, the agency parties to each of these Intergovernmental Agreements have designated Lane County as the agency with fiscal authority; and

WHEREAS, the agency parties to each of these Intergovernmental Agreements have agreed to share the costs of the Motorola Solutions, Inc. contract and other costs of the system in a fair manner allocated among the parties, and will provide such written authorization as is necessary to document the cost sharing; and

WHEREAS, the Lane Manual requires Board approval of any contract in excess of \$100,000 or 3 years in duration;


NOW, THEREFORE, the Board of County Commissioners of Lane County ORDERS as follows:

That the County Administrator be delegated authority to execute a nine-year contract in a form acceptable to the County with Motorola Solutions, Inc., in the amount of \$6,420,139.00; and


That the County Administrator be delegated authority to execute a revised Intergovernmental Agreement with the Lane Regional Interoperability Group parties; and

That the County Administrator be delegated authority to execute such other Memoranda of Understanding as are necessary to document the agreement of the other parties to the Lane Regional Interoperability Group and the 7-County Regional Interoperable Radio System to share in the costs of the Motorola Solutions, Inc. contract.
