WHEREAS, Lane Manual Chapter 20 sets forth policy regarding the competitive award of contracts and policy regarding signatory authority of the County Administrator; and

WHEREAS, Lane County posted Request for Qualified Provider notices for fourteen days and only one response for each project was received; and

WHEREAS, the contract amounts are beyond the County Administrator's delegated authority;

NOW, THEREFORE, the Board of County Commissioners of Lane County **ORDERS** as follows:

1. Sole Source designations in excess of \$100,000 are confirmed in tandem with the selection of the 2016 HUD Continuum of Care grant providers listed in the attachment "2016 HUD Continuum of Care RFQP Sole Respondents"; and
2. Authority is delegated to the County Administrator to sign expense contracts with the providers listed in the attachment "2016 HUD Continuum of Care RFQP Sole Respondents", for the amounts and time periods specified.
