WHEREAS, the Lane County Department of Health & Human Services, Human Services Division, administers homeless programs in Lane County; and

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) has awarded Lane County, on a competitive basis, \$3,461,909 to provide homeless assistance services in order to transition homeless persons into permanent housing and self-reliance.

NOW, THEREFORE, the Board of County Commissioners of Lane County **ORDERS** as follows:


