IN THE MATTER OF ACCEPTING THE 19-21 OREGON CRIMINAL JUSTICE COMMISSION GRANT FOR LANE COUNTY MENTAL HEALTH COURT AND DELEGATING AUTHORITY TO THE COUNTY ADMINISTRATOR TO SIGN GRANT DOCUMENTS AND RELATED CONTRACTS

**WHEREAS**, The Lane County Mental Health Court is a criminal justice model that has proven to reduce criminal recidivism and costs of health care, food stamps, unemployment, child welfare and other costs to the taxpayer; and

**WHEREAS**, the Lane County Sheriff's Office works collaboratively with the Oregon Judicial Department, Emergence, Inc. and Laurel Hill., to prepare grant proposals to fund expanded treatment and counseling services to participants of the Mental Health Court; and


**WHEREAS**, the Board of Commissioners approves all grant awards in excess of \$150,000; and


**WHEREAS**, the Board of Commissioners delegates authority to the County Administrator to sign grant award documents and related contracts.

**NOW, THEREFORE**, the Board of County Commissioners of Lane County **ORDERS** as follows:

1. Delegate authority to the County Administrator to sign the 19-21 OCJC grant documents to accept the award for the Lane County Mental Health Court in the amount of \$460,106.
2. Delegate authority to the County Administrator to execute subcontracts for services as detailed in the grant award.
