ORDER NO. 19-10-15-10

IN THE MATTER OF SETTING A PUBLIC HEARING
FOR THE PROPOSED SURRENDER OF A
PORTION OF 19TH STREET (COUNTY ROAD
NUMBERS 667 AND 1141) AND A PORTION OF
YOLANDA AVENUE (COUNTY ROAD NUMBER 840)
TO THE CITY OF SPRINGFIELD (17-03-24 & 25)

WHEREAS, the City of Springfield, pursuant to Resolution No. 2019-19, dated September 16, 2019, has requested the jurisdiction over portions of 19th Street (County Road No. 667 and 1141) and Yolanda Avenue (County Road No. 840) be transferred to the City of Springfield; and

WHEREAS, the portions of 19th Street and Yolanda Avenue herein proposed for surrender are those portions described in attached Exhibit "A"; and

WHEREAS, the portions of 19th Street and Yolanda Avenue proposed for surrender lie entirely within the city limits of Springfield; and

WHEREAS, ORS 373.270 provides for the surrender and transfer of jurisdiction over county roads within a city, the county may transfer jurisdiction over county roads or parts thereof within a city when it is considered to be necessary, expedient, or in the best interest of the county to do so; and the governing body of the city deems it necessary or expedient and in the best interest of the city to acquire jurisdiction over the county roads or portions thereof and to the same extent as it has over public streets and alleys of the city; and

WHEREAS, the Public Works Director of Lane County has recommended a Public Hearing date be established to consider the offer of surrender to the City of Springfield the portions of 19th Street and Yolanda Avenue as described in attached Exhibit "A", and has provided a written report attached hereto and made a part hereof by this Order, and marked as Exhibit "B"; and

WHEREAS, the Board is of the opinion that setting a date to hold a Public Hearing is in the best interest of the public; and

NOW, THEREFORE, the Board of Commissioners of Lane County **ORDERS** as follows:

1. A Public Hearing be set for **November 12, 2019 at 1:30 p.m.**, time certain, at the Lane County Courthouse, 125 East 8th Avenue, Eugene, Oregon, to formally consider the surrender of portions of 19th Street (County Road No. 667 and 1141) and Yolanda Avenue (County Road No. 840), as described in Exhibit "A", attached and made a part of this Order, to the City of Springfield;
2. Legal notice of the Public Hearing be posted or published, in accordance with ORS 373.270;
3. The Director of the Lane County Department of Public Works to prepare and provide a final report on the proposed surrender.
