The Board is being asked to approve the County's grant application for \$153,194.24 and delegate authority to the County Administrator to accept the award and sign related documents. The funds will be used by the District Attorney's Office to provide services to victims of all crimes.

# Background/Analysis

The County has received this grant for more than 10 years. This grant cycle pays for 0.79 FTE in our Victim Services Program. There is no match requirement for the grant. Grant funds do not cover the County's Full Cost indirect plan. As in previous years, Victim Services' General Fund allotment will cover the indirect costs.
