II. ISSUE

Board approval of the contract award for this remodel is required.

III. DISCUSSION

A. <u>Background:</u>

The Agency is remodeling and upgrading an existing 25-unit apartment complex in Eugene. The needed work includes removal of all damaged or defective plywood siding, repair of dry rot, seismic upgrades, new vinyl windows, new upper floor metal siding system, new painted lower floor wood siding, new below-grade foundation perimeter insulation, new gutters and downspouts, and relocation of all phone, cable tv, and exterior lighting wiring.

B. Analysis

A formal bid package was issued by the Agency for the required work. Three bids were obtained; the lowest responsive bid of \$423,404.00 (Base Bid of \$317,418.00 plus Alternate Number One of \$105,986.00) was submitted by American Tradition Homes, Ltd.

C. Alternatives/Options

In that the public bidding process was employed, the low bid has no irregularities and is responsive and responsible, the prices are considered competitive, and there are sufficient budget funds to cover the project, we recommend award of the contract to American Tradition Homes, Ltd.

D. Recommendation

Approval of the proposed Motion.

E. Timing

Upon bid award, the contractor shall have ten days to provide the Agency with a signed contract. It is anticipated that all other necessary documents could be processed by the second week in December, 2003, and that work would commence soon after.
