Radiology Associates, PC PTNR dba Oregon Imaging Center owns personal property located at 860 Belt Line Road in Springfield, Oregon. They also lease medical equipment from Citicorp Leasing, Inc. Radiology Associates, PC PTNR dba Oregon Imaging Center reported equipment it leases from Citicorp Leasing, Inc. on their 2002-2003 Personal Property Return. Citicorp Leasing, Inc. also filed a Personal Property Return for the 2002-2003 tax year for the same assets. Property taxes on leased equipment/property should only be charged to the leasing company and Citicorp Leasing, Inc. was correct in their filing and thus a double assessment of the equipment was created. This double assessment on Radiology Associates, PC PTNR dba Oregon Imaging Center's account number 5553621 has since been corrected and the assessed value has been lowered.

In October, 2002, the Department of Assessment and Taxation sent a tax statement for the fiscal year 2002-2003 to the owner of record for the property, Radiology Associates, PC PTNR dba Oregon Imaging Center. The taxpayer sent a full payment on November 4, 2002. The payment was processed by the Department of Assessment and Taxation on November 4, 2002.

Due to the above circumstances, the Department of Assessment and Taxation needs to refund per Oregon Revised Statute 311.806(b) the tax amount of \$19,157.94 and statutory refund interest in the amount of \$383.16 computed through January 15, 2003 for a total refund of \$19,541.10. The refund is being issued to the owner of record Radiology Associates, PC PTNR dba Oregon Imaging Center.
