II. **ISSUE OR PROBLEM**

An intergovernmental agreement for the provision of transportation services to clients of Lane County's Developmental Disabilities Program is beyond the signature authority of the County Administrator.

DISCUSSION 111.

Α. Background / Analysis

The state Department of Human Services has forwarded the 2003 - 2005 County Financial Assistance Contract for the purpose, in part, to provide transportation services in the amount of \$777,600 to people with developmental disabilities. Another government entity, Lane Transit District, has been identified as a provider of such services, however the contract amount exceeds the County Administrator's signature authority.

B. Alternatives / Options

- 1. To delegate signature authority, in the amount of \$777,600, to the County Administrator to sign an intergovernmental agreement with Lane Transit District to provide transportation services to people with developmental disabilities.
- 2. Not to accept the motion.

C. Recommendation

To approve number one above.

IV. IMPLEMENTATION

Upon Board action, the Department of Health & Human Services will process the intergovernmental agreement with Lane Transit District.
