

Lane County received two (2) responses from its invitation to bid. The lowest bid was submitted by Farwest Truck Center, with six (6), minor acceptable deviations from the published specifications.

C. Alternatives/Options

1. Purchase the above described equipment unit from Farwest Truck Center at this time.
