#### Ш. DISCUSSION

### A. Background.

The Economic Development Standing Committee (EDSC) was formed in the 1980's as a Board standing committee. Its purpose as described in Lane Manual Section (3.515) is to provide recommendations to the Board regarding Lane County's economic development policies and activities. The current membership of the committee is internal, consisting of two County commissioners, one elected Department Director (County Assessor), and one department manager (Lane Workforce Partnership).

The Economic Development Standing committee decided at its 9/18/03 meeting to recommend that the Board add a lay citizen as the fifth voting member of the committee, and to provide a citizen's perspective in county economic development programs and policies. County Counsel reviewed the recommendation and prepared the Order and specific changes that need to be made to Lane Manual to be consistent with amendment practices.

### B. Analysis.

Adding a lay citizen member to the committee will provide a citizen perspective that is not connected to Lane County's on-going economic development activities. This will provide citizen input to a process that has been internal to this point in time. Also, adding a fifth member to the committee will help in the voting process. However, if a citizen member is added to this committee, it will transform it from a strictly internal County committee to a more regular advisory committee. The lay citizen position is defined as "not a vendor", as described in Lane Manual 3.506 (2) (d), which reads: "Conflicts of Interest. In furtherance of the laws relating to conflicts of interest, no vendor shall serve on any advisory committee or board that deals with or makes recommendations on or awards of contracts with the vendor. In this context, "vendor" means any individual, partnership, joint venture, corporation, private non-profit organization or private for-profit organization who seeks to obtain a contract with the County to provide a service or product on some type of regular basis, i.e., more
