A. Background

Lane County has an Intergovernmental Agreement with City of Springfield to provide five (5) jail beds for the confinement of Springfield Municipal Court Prisoners.

Agreement between Lane County and City of Springfield began 1 July 2003 and ends 30 June 2005.

The Intergovernmental Agreement provided funding in the amount of \$156,940 for the period of 1 July 2003 through 30 June 2004 and approved under Board Order 03-6-18-2.

Amendment No. One (1) increases the cost of incarceration beginning 1 July 2004 and ending 30 June 2005.

This amendment provides funding in the amount of \$164,852.

B. Analysis

Lane County should take advantage of generating additional revenue for providing five (5) jail beds for City of Springfield Municipal Court Prisoners.

C. Alternatives/Options

- 1. Adopt the Order to approve Amendment No. One (1) to Intergovernmental Agreement.
- 2. Do not approve the order.
