WEST OF THE WILLAMETTE MERIDIAN (17-03-31) (17-04-36)

I. MOTION

MOVE TO APPROVE THE FINAL ORDER ESTABLISHING THE FAIRGROUNDS WEST ENTRANCE ROAD AS COUNTY ROAD, BEING MORE PARTICULARLY DESCRIBED IN EXHIBIT 'A' OF THE FINAL ORDER OF ESTABLISHMENT.

II. ISSUE

Improvements associated with the construction of the Fairgrounds West Entrance Road project have been completed. It is necessary to decide whether the completed road project and its alignment should be legally established as county road.

III. DISCUSSION:

A. Background

Through the adoption of the Amendment of the Capital Improvement Programs for FY 1995-1996 through FY 1999-2000 by Order and Resolution No. 96-2-14-5, the Board of County Commissioners approved construction of roads to serve the Lane County Fairgrounds. These roads would provide better service and access from West 13th Avenue to the Lane County Fairgrounds and would be of benefit to the public. Phase 1 of this project has been completed and accepted as a county road for maintenance purposes. The Fairgrounds West Entrance Road is Phase 2 of this project.

The road in the Fairgrounds West Entrance Road project (Phase 2) lies within the Fairgrounds property, which is presently owned by Lane County. The Fairgrounds property lies within the limits of the City of Eugene. The Lane County Home Rule Charter and ORS 373 provide that the County may enter into agreements with cities to expend funds in the acquisition of right-of-way, improvement, construction or repairs of streets within cities. In accordance with Order No. 97-4-30-5, Lane County and the City of Eugene have entered into an Intergovernmental Agreement dated June 16, 1997 wherein both jurisdictions agree to the cooperation of responsibility for the

construction and maintenance of the roads in the Fairgrounds West Entrance Road project (Phase 2).

The Fairgrounds West Entrance Road project including surveying, alignment design, mapping, and construction relative to this project has now been completed. The project was constructed in accordance with plans and specifications administered by the Lane County Department of Public Works Director.

B. Analysis

The construction of the road in the Fairgrounds West Entrance Road project (Phase 2) has been completed and the road is open for public travel. The final phase of the project is to complete the legal establishment of the road in accordance with ORS Chapter 368. The Final Order of Establishment accomplishes that action, including the dedication and acceptance of portions of County owned land as right of way in conjunction with this project. The centerline description of the alignment including right of way widths is attached to the Final Order as Exhibit "A".

The road does not meet all criteria for acceptance as a county road in that the width of 50 feet does not meet the 60 foot standard right of way width as specified in Lane Manual 15.220 (2), however, a Right of Way Certification is prepared to accommodate this acceptance, as provided for in Lane Manual 15.222, and is attached to the Final Order as Exhibit "C".

The Public Works Department has filed a road survey (CSF 37295), which includes road centerline and right of way monumentation in compliance with ORS Chapters 209.250 and 368.106 for public record in the County Surveyor's Office and in the County Road Files administered by the Public Works Department and the County Surveyor.

C. <u>Alternatives/Options</u>

The Board of Commissioners has the options of:

- 1. Approving the Final Order of Establishment for the Fairgrounds West Entrance Road project or
- 2. Having staff review and alter any component of the Final Order of Establishment of said Fairgrounds West Entrance Road project, or
- 3. Continue the proposed motion for further consideration

D. Recommendations

It is recommended that the Board of County Commissioners approve Option 1. This will approve the Final Order of Establishment to establish the road in the Fairgrounds West Entrance Road project (Phase 2) as county road as proposed and supported by the Public Works Director.

E. Timing

Timing is important, as ORS 368.106 requires that the Final Order of Establishment be recorded. Also, establishing this road as a county road will allow it to be included as part of the Lane County Road Maintenance System.

IV. IMPLEMENTATION/FOLLOW-UP:

The Final Order of Establishment will be forwarded to the County Clerk for filing and entry into the Commissioners' Journal of Administration. The Final Order and the road survey will be entered into the Road Index Books and the County Road files administered by the Department of Public Works and the County Surveyor for public record.

THIS MATTER now coming before the Board of County Commissioners for Lane County, Oregon, and the Board through adoption of the Capital Improvement Program for the Department of Public Works has determined that it was necessary to construct roads that will provide better service and access from West 13th Avenue to the Lane County Fairgrounds; and

WHEREAS, through adoption of the Amendment of the Capital Improvement Programs FY 1995-1996 through FY 1999-2000 and by Order and Resolution No. 96-2-14-5, the Board of Commissioners approved the construction of roads to serve the Lane County Fairgrounds and Phase 1 of the project has been completed and accepted as county road; and

WHEREAS, the Fairground property is owned by Lane County and lies within the city limits of Eugene and the Lane County Home Rule Charter and ORS 373 provide that the County may enter into agreements with cities to expend funds in the acquisition of right-of-way, improvement, construction or repairs of streets within cities; and

WHEREAS, Lane County and the City of Eugene have entered into an Intergovernmental Agreement dated June 16, 1997 wherein both jurisdictions have agreed to cooperate in the construction and maintenance of the road in Phase 2 of the Fairgrounds Entrance project; and

WHEREAS, Lane County is the sole owner of the land on or over which the road in the Fairgrounds West Entrance project (Phase 2) has been laid out and the road has been constructed in accordance with the plans and specifications prepared and administered by the Director of the Public Works Department; and

WHEREAS, by provisions of ORS 368.106 the road in the Fairgrounds West Entrance Road project (Phase 2) and the alignment and right of way of said road needs to be established as county road right of way; and

WHEREAS, the Department of Public Works has filed a road survey (County Survey File 37295) with the County Surveyor for public record and for the County Road files all in compliance with ORS chapters 209.250 and 368.106; and

WHEREAS, the road does not meet all criteria for acceptance as a county road, however, Lane Manual 15.222 provides that the Board of County Commissioners may waive or modify standards or policy criteria; and

WHEREAS, the Board of County Commissioners being satisfied that necessary road construction and improvements have been completed and will be of public utility and benefit; now therefore, it is hereby

ORDERED, that the portions of County owned land, acquired by Lane County as set forth below, included within the limits of the said road as described herein be hereby dedicated to the public for road purposes and accepted as County Road right of way:

I, Oliver P. Snowden, Director of the Lane County Department of Public Works, pursuant to Lane County Board of Commissioners adoption of the Amendment of the Five Year Capital Improvement Programs for FY 1995-1996 through FY 1999-2000 by Order and Resolution No. 96-2-14-5, do hereby report that the Department has proceeded with the improvement and construction for the Fairgrounds Entrance project to provide better service and access from West 13th Avenue to the Lane County Fairgrounds. Phase 1 of the Fairgrounds Entrance project has been completed and accepted as county road for maintenance purposes. The road in the west portion of the Fairgrounds entrance project is Phase 2 of the project.

The road in the Fairgrounds entrance road project (Phase 2) lies within the Fairgrounds property, which is presently owned by Lane County. The Fairgrounds property lies within the city limits of Eugene. The Lane County Home Rule Charter and ORS 373 provide that the County may enter into agreements with cities to expend funds in the acquisition of right-of-way, improvement, construction or repairs of streets within cities. For the benefit of the public and in accordance with Order No. 97-4-30-5, Lane County and the City of Eugene have entered into an Intergovernmental Agreement dated June 16, 1997 wherein both jurisdictions agreed to cooperate in the responsibility for the construction and maintenance of the Fairgrounds entrance project.

The Fairgrounds West Entrance Road project (Phase 2) construction plans were prepared, and all necessary surveying, alignment design and mapping, and construction has been completed. All construction of this project was completed in accordance with plans and specifications administered by the Department of Public Works.

The road does not meet all criteria for acceptance as a county road in that the width of 50 feet does not meet the 60 foot standard right of way width as specified in Lane Manual 15.220 (2), however, a Right of Way Certification is prepared to accommodate this acceptance, as provided for in Lane Manual 15.222, and is attached to the Final Order as Exhibit "C".

A Final Order to legally establish this road has been prepared. The Order provides for the dedication and acceptance of portions of county owned land as right of way in conjunction with this project. The legal descriptions of the alignment including right of way widths are marked Exhibit "A" and attached to the Final Order of Establishment.

The Department of Public Works has filed a road survey (CSF 37295), which includes centerline and right of way monumentation, with the County Surveyor for public record all in compliance with ORS Chapters 209.250 and 368.106.

The public interest will be served, as it will establish the Fairgrounds West Entrance Road project as a county road and will allow it to be included as part of the Lane County Road Maintenance System. It is therefore recommended that the Final Order of Establishment be approved and that it be filed with the County Clerk's Office and entered in the Commissioner's Journal of Administration. It is also recommended that the Final Order and road survey be entered into the Road Index Books and the legal County Road files administered by the Department of Public Works and the County Surveyor for public record.

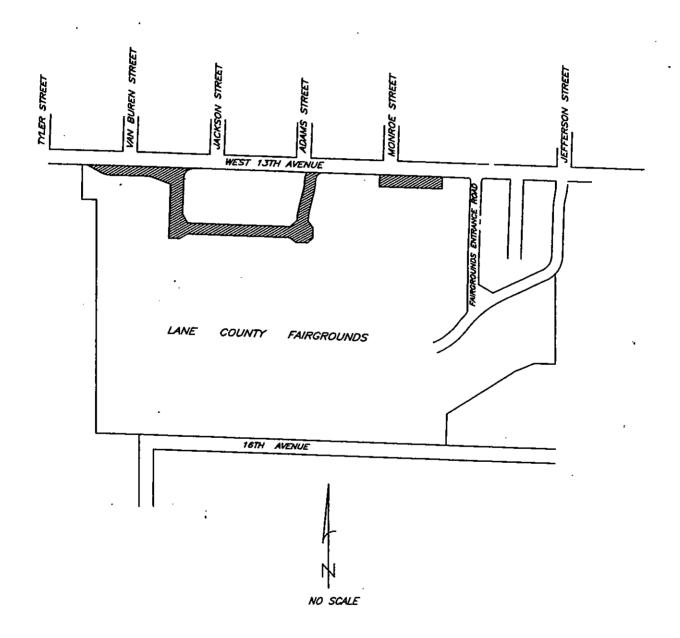

The Fairgrounds West Entrance Road project provides service and access to the Lane County Fairgrounds. Through the adoption of the Amendment of the Capital Improvement Programs for FY 1995-1996 through FY 1999-2000 and Board Order No. 96-2-14-5, the Board of Commissioners' approved construction of roads to serve the Lane County Fairgrounds. The road would provide better service and access from West 13 th Avenue to the Fairgrounds and would be of benefit to the public. The road does not meet all criteria for acceptance as county road in that the right of way width of 50 feet does not meet the 60 foot standard right of way width as specified in Lane Manual 15.220(2).
Lane Manual 15.222 makes provisions for the acceptance of roads having a width less than 60 feet provided that certification regarding future needs and safety considerations are made by the Director of the Department of Public Works and the Director of the Planning Division. Certification statements meeting the specified criteria are as follows:
I, Oliver P.
