IN THE MATTER OF AMENDING CHAPTER 60 OF THE LANE MANUAL TO ESTABLISH FEES CHARGED BY THE COUNTY ADMINISTRATOR FOR REAL PROPERTY COMPENSATION CLAIM APPLICATIONS RESULTING FROM BALLOT MEASURE

37 (NOVEMBER 2, 2004) (LM 60.842)

I. MOTION: I move to approve the order.

II. ISSUE OR PROBLEM: The effective date of Ballot Measure 37 is December 2, 2004. In order to establish fees for processing claims, amendments must be made to LM 60.842.

III. DISCUSSION: On November 2, 2004, Oregon voters approved Ballot Measure 37 to add provisions to ORS Chapter 197 to require payment to landowners if a government land use regulation reduces private real property value. Since Ballot Measure 37 does not specify a method for making claim applications, draft Lane Code provisions have been prepared to establish such a process. Ordinance No. 18-04 presents a claim application process for Board consideration. It includes authorization for fees to be set by Board Order. The proposed changes to Lane Manual reflect the approval of Ballot Measure 37 and set initial fees at \$750 plus notice costs of \$100. in addition, the proposed fee provisions enable billing for additional costs in the event the initial fees are not sufficient to cover actual county costs. If the Board elects to compensate a property owner, the fees will be refunded.

In addition, the applicant shall pay to the county \$100.00 for notice costs as required by the County Administrator. In the event the initial application fee or notice cost payments are not sufficient to cover all of the County costs as determined by the County Administrator, the applicant shall pay the balance of the actual county costs upon receipt of an appropriate billing statement from the County. The County shall refund the application fee and costs paid by the applicant if it is determined by the County or by a court or other reviewing body that the applicant is entitled to compensation under the provisions added to ORS Chapter 197 by Ballot Measure 37 (November 2, 2004) and the County compensates the applicant. 60.842 Fees for Real Property Compensation Claim Application.

(Revised by Order No. 02-6-26-8, Effective 7.1.02)

Pursuant to Lane County Charter, Chapter II, Section 5, and LC 2.700 through 2.9770, a fee is established to partially cover County costs of processing an application filed to seek compensation under the procedures in LC 2.700 through 2.770. Unless waived by the County Administrator, an application for a claim of compensation from Lane County pursuant to Article I, Section 18(a) through (f) of the Oregon Constitution the provisions added to ORS Chapter 197 by Ballot Measure 37 (November 2, 2004) and LC 2.700 through 2.770 shall include an application fee of \$850750.00 for the initial costs incurred by the County in processing the application. In addition, the applicant shall pay to the county \$100.00 for notice costs as required by the County Administrator. In the event the initial application fee or notice cost payments are not sufficient to cover all of the County costs as determined by the County Administrator, the applicant shall pay the balance of the actual county costs upon receipt of an appropriate billing statement from the County. The County shall refund the application fee and costs paid by the applicant if it is determined by the County or by a court or other reviewing body that the applicant is entitled to compensation under Article I, Section 18(a) through (f) of the Oregon Constitution the provisions added to ORS Chapter 197 by Ballot Measure 37 (November 2, 2004) and the County compensates the applicant.
