#### I. MOTION

IN THE MATTER OF APPROVING AN AMENDMENT TO THE 2003-04 COMMUNITY CORRECTIONS PLAN AND APPROPRIATING AN ADDITIONAL \$29,075 IN REVENUE AND EXPENSES IN FISCAL YEAR 2003-04 (DEPARTMENT OF HEALTH & HUMAN SERVICES).

#### II. ISSUE OR PROBLEM

Lane County has an approved Community Corrections Plan for the 2003-05 biennium with the State Department of Corrections. The Public Safety Coordinating Council recommends approval of an amendment to the plan, in order to add a Sex Offender Housing facility to the plan. Amendments to the plan require the approval of the Board of County Commissioners.

#### III. DISCUSSION

#### A. Background / Analysis

On June 18, 2003, the Board approved the Lane County Community Corrections plan for the 2003-05 biennium. The 2003-05 Intergovernmental Agreement (IGA) forwarded at that time reflected a significant decrease in funding from the beginning of the prior biennium. Therefore, the 2001-03 biennium IGA was extended through October 31, 2003.

On October 29, 2003, the Board accepted Intergovernmental Agreement #2942 with the Oregon Department of Corrections for the period of November 1, 2003 to June 30, 2005. This IGA included approximately \$3 million dollars in funding above the total in the first IGA forwarded for 2003-05. This additional

funding was to be provided in part through the income tax surcharge approved by the state legislature, which is now being voted on as Ballot Measure 30. If the additional funds in the state budget are impacted by a possible referendum in February, the estimate of the greatest change in Lane County funding will be to drop the addition of \$3,146,846 down to \$487,205.

There were two changes to the CCA plan and the budget that was forwarded with the 2003-05 IGA. These included establishing one FTE support staff position for data collection on the state IGA performance measures to be funded beginning January 2004 and, awarding a two percent cost-of-living allowance for corrections program funding in the second year of the biennium, beginning July 1, 2004. The amount of CCA funding that will remain whether or not the tax surcharge continues will be enough to fund the planned data entry clerk position and the two percent C.O.L.A. with a balance of \$225,265.

At the December 11, 2003 meeting of the Public Safety Coordinating Council (PSCC), the Supervisory Authority Team (SAT) brought forward a proposal to use community corrections funding in support of a 15 to 19 bed rental housing facility for high-risk male sex offenders. The PSCC accepted the proposal and now seeks to have the Board approve this revision to the 2003-05 CCA Plan.

The housing facility would be a new project representing a collaboration between Sponsors and Lane County Parole & Probation. It would provide access to stable, supervised housing for male sex offenders who otherwise may be homeless or living in neighborhoods where they pose a risk to the immediate community.

At this time, no formal programming is recommended for this facility, due to staff and resource limitations. The facility will, however, include an office for a Probation and Parole officer and a night manager.

The objectives for the project include:

- 1. Enhance public safety by closer monitoring of high-risk sex offenders;
- 2. Reduce recidivism among participants;
- 3. Reduce the number of technical violations among participants:
- 4. Increase or maintain the employment rates of participants:
- 5. Increase the percentage of positive probation, parole and post-prison supervision case closures among participants.

The primary supervision will be provided by a parole officer stationed at the facility. An office has been set aside for that purpose. Parole & Probation currently has a similar situation at Sponsors' facility at 1756 Willamette Street with two parole officers stationed there. It has produced excellent results, with their presence complementing Sponsors staff in a cooperative and effective

public/private partnership. The parole officer will be on duty from 8:00 a.m. to 5:00 p.m. Monday through Friday. In addition, a resident manager employed by Sponsors will work from 9:00 p.m. to 7:00 a.m. Wednesday through Sunday. This will leave Monday and Tuesday night, Wednesday through Friday evenings, Saturday and Sunday days and staff vacations and sick time without on-site staff.

The cost of the project will include \$12,325 in start-up costs and \$33,500 per year with the first fiscal year discounted to \$16,750 for the six-month period: a total of \$62,575 for the two-year period. These funds will be covered by the \$225,265 CCA funds that are designated as unallocated at this time and will remain whether or not the tax surcharge is supported by the voters in February. This change requires completion of a Plan Amendment with county commissioner approval to be forwarded to the state.

A competitive process was completed in November 2003 and Sponsors was determined to be the only qualified provider interested in this project. The amount of funding for the 2003-05 fiscal period falls within the 20 percent rule and may be added to the Sponsors contract without board action.

However, none of the unallocated CCA funds have been appropriated. Therefore, the Board will be asked to accept the modification to the CCA Plan as recommended by the PSCC and to appropriate the additional \$29,075 to fund the project for the 2003-04 fiscal year.

## B. Alternatives / Options

- To accept the motion approving the CCA Plan Amendment that adds supervised housing for high-risk sex offenders as recommended by the PSCC and to appropriate the \$29,075 to fund the project for the 2003-04 fiscal year.
- 2. Not to accept the motion.

# C. Recommendation

To approve number one above.

#### D. Timing

Sponsors plans to sign a lease on the housing property effective January 1, 2004. Therefore, the CCA Plan Amendment form must be approved and funds appropriated immediately to support the contract and inform the state.

# IV. IMPLEMENTATION

Upon action by the Board, the CCA Plan Amendment form will be forwarded to the Oregon Department of Corrections and the amendment to the Sponsors contract will be processed for signature.
