I. MOTION

II. ISSUE

Board approval is required to award a contract for the exterior painting at Village Oaks Apartments located in Eugene, Oregon .

III. DISCUSSION

A. Background:

The Agency as part of its routine maintenance of its housing stock paints on an as needed and periodic basis. The apartment complex know as Village Oaks is now in need of painting and the funds are available through our maintenance reserve funds for this project.

B. <u>Analysis</u>

A formal bid process with a bid package was issued by the Agency for the required work, and the project was advertised in local papers. Six responsive bids were obtained, and the lowest bidder is both responsive and responsible and they have reviewed their bid and confirmed their costs.

C. <u>Alternatives/Options</u>

In that the public bidding process was employed, the lowest total bid of \$51,000 has no irregularities and is responsive and responsible, the prices are considered competitive, and there are sufficient budget funds to cover the project, we recommend award of the contract to Ace Classic Painting.

D. Recommendation

E. Timing

Upon bid award, the contractor shall have ten days to provide the Agency with a signed contract. It is anticipated that all other necessary documents could be processed by June 21,2004 and work would commence shortly thereafter.
