I. PROPOSED MOTION

MOVE APPROVAL OF THE ORDER AND RESOLUTION IN THE MATTER OF APPOINTING MEGAN LARSON TO THE LANE COUNTY COMMISSION ON CHILDREN AND FAMILIES.

II. ISSUE OR PROBLEM

The Lane County Board of Commissioners has the appointing authority for membership on advisory boards and commissions pursuant to the Lane Manual and to HB 2004, and therefore approves recommendations for appointment to the Lane County Commission on Children and Families.

III. DISCUSSION

A. Background/Analysis

On February 11, 2004 the Board of County Commissioners appointed Crystal Argetsinger to the Lane County Commission on Children and Families at the request of the Commission. Following the appointment department staff and Commission members made many attempts to connect and engage with Crystal Argetsinger without response through phone calls, emails, and letters.

At this time the Lane County Commission on Children and Families is requesting that Crystal Argetsinger's nonparticipation be considered a form of resignation, and that the Board of Commissioners appoint Megan Larson as her replacement.

The recommended candidates are listed below, followed by the expired or resigned position they will be filling, and the expiration date of their term. Attachment A: Recommended Applicant for Appointment to the LCCCF.
