I. MOTION

TO PROCLAIM MARCH 17, 2004 AS LANE COUNTY ALCOHOL-FREE ST.

PATRICK'S DAY

II. ISSUE OR PROBLEM

Celebrating St. Patrick's Day and honoring Irish heritage does not require drinking alcohol; yet St. Patrick's Day has become synonymous with drinking green beer. There is a rich precedent for non-alcohol celebrations in Lane County.

III. DISCUSSION

A. <u>Background / Analysis</u>

Alcohol has become such an ingrained part of St. Patrick's Day in Lane County that even people who claim Irish heritage, (more than 10 % of Lane County residents), are often quick to attribute green beer and other Irish related alcohol to Irish heritage with little to no idea of what truly comprises Irish culture. Creating a precedent for a non-alcohol gathering would demonstrate that positive community expression in Lane County does not need to automatically include alcohol.

'First Night' was founded in Boston in 1976 to stage community New Year celebrations featuring visual and performing arts in a non-alcoholic environment. Families are encouraged to participate through activities for children and adults. "First Night" has addressed drunk driving problems in communities and has provided a safe atmosphere for New Year's eve revelry.

The First Annual Eugene Irish Cultural Festival, an alcohol-free, family-focused event, has partnered with numerous community organizations, including Lane County

County Health & Human Services, City of Eugene, Eugene Community Partnership, media, and local businesses. The festival relies on community spirit, ethnic heritage, and appreciation of the arts. The festival is intended to begin discussion and awareness of healthy celebrations of Irish traditions. The festival will be an Irish cultural celebration without alcohol. Family entertainment and education will come together in downtown Eugene on March 13-14, 2004, (the weekend before St. Patrick's Day), with crafts, music, Irish dancing, children's activities, educational materials and costume contests.

The goal of Lane County Irish Heritage St. Patrick's Day and the festival is to shift the holiday focus away from alcohol and to begin an annual tradition of families celebrating Irish culture.

B. <u>Alternatives / Options</u>

- 1. To declare March 17, 2004 as Lane County Irish Heritage St. Patrick's Day.
- 2. Not to declare March 17, 2004 as Lane County Irish Heritage St. Patrick's Day.

C. Recommendation

To approve number one above.

D. <u>Timing</u>

Upon Board approval, March 17, 2004 will be designated as Lane County Irish Heritage St. Patrick's Day.

IV. IMPLEMENTATION

Upon approval by the Board, implementation will be completed as stated above in Timing.
