I. PROPOSED MOTION:

IT IS MOVED THAT MALLARD CONSTRUCTION BE AWARDED CONTRACT 04-C-0004 FOR REHABILITATION OF THE MUNSEL PARK APARTMENTS IN FLORENCE, THAT AN ORDER TO THIS EFFECT BE SIGNED, AND THAT AN AGREEMENT BE EXECUTED.

II. ISSUE:

Board approval is required to award a contract for rehabilitation work at the Munsel Park Apartments in Florence.

III. DISCUSSION:

A. Background

In June 2003, HACSA acquired the Munsel Park Apartments, a 44-unit Rural Development "preservation" project in Florence. As part of this acquisition, funds were set aside for rehabilitation of the project. Because the proposed work program would have involved substantial inconvenience to the residents during the winter months, rehabilitation was scheduled to begin this spring.

The proposed work program includes:

* Replacement of deteriorated stairways, upper walkways, and balconies;

- Making three units fully accessible for households with disabilities;
- * Exterior painting:
- * Installing new sliding glass patio doors;
- * Accessibility improvements to the community room bathroom and kitchen;
- Miscellaneous siding replacement and dryrot repair as necessary.

B. Analysis

In March 2004, HACSA issued two formal bid packages ("Improvements to Munsel Park Apartments" and "Accessibility Remodel at Munsel Park Apartments") to carry out the proposed work program. Mallard Construction was the low-bidder for both these packages.

C. Alternative/Options

In that the public bidding process was employed, the low bid has no irregularities and is responsive and responsible, the prices are considered competitive, and there are sufficient budget funds to cover the project, we recommend award of the contract to Mallard Construction.

D. Recommendation

Approval of proposed motion.

E. Timing.

Upon bid award, the contractor shall have ten days to provide the Agency with a signed contract. It is anticipated that work will begin as soon as possible.
