COMMITTEE CHARGE:

Provides assistance and advice to the Board of Commissioners and the Human Services Commission's Community Health Centers of Lane County (CHCLC). The Council's mission is to provide comprehensive health care that is quality-driven, affordable and culturally competent to low-income, uninsured, and underinsured people. The Council will provide input and feedback to generally advise the development, implementation and evaluation of CHCLC programs, including but not limited to, all programs funded through the Federal Bureau of Primary Health Care grant. In addition, guidance regarding the health care needs of Lane County residents will also be invited. The Council will review marketplace trends and provide assistance and advice that reflect Lane County economic realities.

The Advisory Council will have authority to review and recommend program policies for CHCLC. Responsibilities include:

- 1. Participation in planning and review of the CHCLC's budget throughout the year, as well as approval of the annual budget and grant applications.
- 2. Participation in planning, measurement, and evaluation of the CHCLC's progress in meeting its annual and long-term programmatic and financial goals.

- 3. Participation in selection of the services provided by the CHCLC's and determination of the hours during which services are provided at service sites.
- 4. Participation in the adoption of health care policies regarding scope and availability of services.

MANDATED: Section 330 of the Public Health Service Act

C. BACKGROUND / ANALYSIS:

As a federally qualified health center a 15 member Advisory Council has been created that includes consumers, health care, and community representatives. A majority of members of the council (eight) must be people who are served by the CHCLC, consumer members, and who as a group represent the individuals being served. The remaining seven are non-consumer community representatives of which no more than half may derive their annual income from the health care industry.

In February, the Board of County Commissioners appointed nine members to the Community Health Center Advisory Council, seven of which were non-consumer representatives and two that were consumers. The three health care appointees included representatives of three major community health partners, Peace Health, McKenzie Willamette, and LIPA. The four non-health care community member positions included the superintendent of Springfield School District 19, executive directors of the regional Latino and HIV social service organizations, and a retired health educator.

Staff, with the assistance of the current appointees, reviewed and recommended the following six consumer representatives for appointment. The following is a brief description of each recommended appointee.

- 1. Grace Almeida Senior and disabled foster care provider in Springfield.
- 2. Maria Bassani Cottage Grove resident and recent immigrant from Argentina with background in community economic development and social services
- 3. Pamela Driscoll Substitute teacher for Head Start of Lane County in Springfield
- 4. Bill Dwyer County Commissioner and Springfield resident
- 5. Marianne Malott Formerly homeless person who is involved in church social services committee
- 6. Myrna Toledo Counselor and care manager employed at CentroLatino

Another option to be considered, approved by the Advisory Council, was to create a County Commissioners liaison and appoint a consumer other than Commissioner Dwyer to the committee.

The Lane Manual allows for three-year terms, ending June 30. In establishing this new advisory council, staff has randomly assigned staggered terms to allow for continuity and renewal over time.

3. That the property can be served by the orderly and efficient extension of key urban facilities and services as prescribed in the Metro Plan prior to or in conjunction with development.

Serving the land within the DWP Overlay District with the orderly and efficient extension of key urban facilities and services will not be effected by adoption of the Overlay District. The Public Utilities, Services, and Facilities Element of the Metro Plan considers the provision of water a key urban service. The purpose of the Overlay District is to protect from contamination the aquifers used as the potable water supply sources for the City of Springfield and keep them available for use.
