## Nature of Proceeding and Order:

This is an order in the appeal of the recommendation issued by the Lane County Sheriff's Office (LCSO) to the Oregon Liquor Control Commission (OLCC) to deny a liquor license application by Steve Nelson and Kevin B. Hill. The appeal is pursuant to Lane Manual 16.120. The Hearings Official has been delegated authority by the Board of Commissioners to conduct the appeal and make a recommendation to the Board that the Board recommend to OLCC either approval or denial of the license application, which recommendation may supercede that of the Sheriff.

Ruling: The Hearing Official recommends that the LCSO recommendation is reversed.

## **Applicable Lane Manual Section:**

The LCSO relies on the following regulations:

Section 16.120(4), provides that:

"The Sheriff may recommend denial of a license application if any of the following factors exist:

- a) Failure to meet applicable land use requirements.
- b) A felony conviction of the applicant, or any officer or director of the applicant.
- c) Two or more misdemeanor convictions within the preceding 10 years of the applicant, or any officer of director of the applicant.
- d) A history of involvement by the applicant, or any officer or director of the applicant, in incidents involving drugs or alcohol.
- e) Any factor identified and explained in the Sheriff's recommendation as a risk to the public health and safety."

- The evidentiary record in this proceeding consists of one (1) tape cassette recording of the March 21, 2005, hearing and the following exhibits:
- Letter dated February 4, 2005 from Byron Trapp, Sergeant, Police Services
  Division, on behalf of the Sheriff, to the applicants, informing the latter that
  LCSO was recommending that the OLCC deny their liquor license application.
- Letter dated February 9, 2005 from the applicants to the Lane County Board of County Commissioners appealing the denial and requesting a hearing.
- Board Order 05-3-9-19 scheduling a hearing of the appeal and designating a Hearings Official.
- Letter dated March 10, 2005 from the Hearings Official to the applicants notifying latter of the hearing.
- Lane Manual 16.100-130 dealing with License for Sale of Alcoholic Liquor.
- Handwritten notes dated March 21, 2005 from the Hearing Official.
