AND 1930) TO THE CITY OF COTTAGE GROVE.

#### T. **MOTION**

To Approve the Order to Surrender Jurisdiction of a Portion of Lincoln Avenue (County Road Number 1131) and a Portion of South 10<sup>th</sup> Street (County Road Numbers 1163 and 1930) to the City of Cottage Grove.

#### II. ISSUE

To decide whether or not to approve the Order to surrender the jurisdiction of a portion of Lincoln Avenue (County Road Number 1131) and South 10th Street (County Road Numbers 1163 and 1930) to the City of Cottage Grove.

#### III. DISCUSSION

#### A. Background

The City of Cottage Grove is requesting the surrender of portions of Lincoln Avenue (County) Road Number 1131) and South 10th Street (County Road Numbers 1163 and 1930) being described in Exhibit "A" and shown on Attachment "A" and being located within the city limits. The subject portion of Lincoln Avenue and the portion of South 10th Street south of Lincoln Avenue were annexed into the City of Cottage Grove in 1999 by Annexation EC CG 99-69. The portion of South 10th Street between Cooper Avenue and Lincoln Avenue was annexed into the City by Annexation EC CG 01-25 in 2001.

The portion of Lincoln Avenue (formerly known as Nokes Avenue and Vinal T. Randall Road) was established as a county road in 1936 with a right of way width of 50 feet. South 10<sup>th</sup> Street (formerly known as South Mill Street) was established as a county road in 1939 with a right of way width of 60 feet.

The City of Cottage Grove has enacted Resolution Number 1432, formally requesting that the jurisdiction over the above described portions of County Roads, all within the city limits and described in the attached Order, be transferred from Lane County to the City of Cottage Grove. The proposed surrender is in accordance with the County/City Road Partnership Agreement of July 1, 2004.

Resolution and Order No. 04-12-8-3 set a public hearing date of January 3, 2005, before the Board, to consider the merits to transfer jurisdiction of the subject roads to the City of Cottage Grove. If the Board approves the surrender of jurisdiction of Lincoln Avenue (County Road Number 1131) and South 10<sup>th</sup> Street (County Road Number 1163 and 1930), it will complete the road surrender process.

All legal notice has been provided regarding this matter as required by ORS 373.270 (2).

#### B. Analysis

ORS 373.270 provides for the transfer of jurisdiction over County Roads within a city. The subject portions of Lincoln Avenue and South 10<sup>th</sup> Street are within the city limits of Cottage Grove, but are under the jurisdiction of Lane County and are currently being maintained by Lane County Public Works Department. The proposed surrender of these segments of roads will transfer the jurisdiction to the City of Cottage Grove and allow the City to maintain, develop and improve them as necessary to the City's specifications, standards, and timetable.

The proposed surrender is in accordance with the County/City Roads Partnership Program Agreement of July 1, 2004. The proposed surrender of this 0.03 mile portion of Lincoln Avenue and 0.09 mile portion of South 10<sup>th</sup> Street may slightly increase the payment to the City of Cottage Grove but it would not increase the overall total payment by the County to cities in the County/City Partnership Program Agreement of July 1, 2004. The public's interest was determined to be benefited when this agreement was reached.

The attached Order will complete the surrender process and transfer of jurisdiction of the described portions of roads to the City of Cottage Grove as requested by the City.

#### C. Alternatives/Options

The Board of County Commissioners has the options to:

- 1. Approve the Order to surrender jurisdiction of the portion of Lincoln Avenue (County Road Number 1131) and South 10<sup>th</sup> Street (County Road Number 1163 and 1930) to the City of Cottage Grove.
- 2. Deny the Order to surrender jurisdiction of the portion of Lincoln Avenue (County Road Number 1131) and South 10<sup>th</sup> Street (County Road Number 1163 and 1930) to the City of Cottage Grove.
- 3. Postpone further action until a future date.

### D. Recommendations

The Public Works Director's Report recommends that the Board of Commissioners approve Option 1. This will approve the Order to surrender jurisdiction of the portions of Lincoln Avenue and South 10<sup>th</sup> Avenue, as described in the Final Order, to the City of Cottage Grove.

## E. Timing

Timing in this matter is important as the surrender of County roads is part of the County/City Roads Partnership Program Agreement and would address the resolution submitted by the City of Cottage Grove to transfer jurisdiction of the described portions of the county roads.

#### IV. IMPLEMENTATION/FOLLOW-UP

Upon approval of the Order transferring jurisdiction of these roads, the County's involvement in the process will be concluded. The County Clerk shall file the Order in the Commissioner's Journal of Administration and forward copies to the Lane County Surveyor and Public Works Director for updating appropriate indexes and County Road records.

WHEREAS, the City of Cottage Grove has enacted Resolution Number 1432, formally requesting that the jurisdiction over a portion of Lincoln Avenue (County Road Number 1131) and a portion of South 10<sup>th</sup> Street (County Road Numbers 1163 and 1930) which lie within the city limits, be transferred to the City of Cottage Grove; and

WHEREAS, ORS 373.270 provides for the transfer of jurisdiction over county roads within a city. The County may transfer jurisdiction over county roads, or parts thereof, within a city when it is considered to be necessary, expedient, or in the best interest of the county to do so; and the governing body of the city deems it necessary or expedient and in the best interest of the city to acquire jurisdiction over the county roads or portions thereof and to the same extent as it has over public streets and alleys of the city; and

WHEREAS, all legal notice has been provided regarding this matter as required by law as witnessed by an Affidavit of Posting by the Lane County Surveyor marked as Exhibit "C", attached hereto and made a part hereof, and the Public Works Director of Lane County recommends that the portion of Lincoln Avenue (County Road 1131) and South 10<sup>th</sup> Street (County Road Number 1163 and 1930) be surrendered; as shown on the Final Director's Report, Exhibit "B" attached hereto, and made a part hereof, by this order; and

WHEREAS, there are no known objections to the proposed surrender, and it appears that the surrender of the described portion of Lincoln Avenue (County Road Number 1131) and South 10<sup>th</sup> Street (County Road Numbers 1163 and 1930) would be in the best interest of the county; now therefore it is hereby

**ORDERED,** that Lane County, in accordance with ORS 373.270, hereby surrenders jurisdiction of the portion Lincoln Avenue (County Road Number 1131) and South 10<sup>th</sup> Street (County Road Numbers 1163 and 1930) as described in Exhibit "A", attached hereto and made a part hereof by this Order, to the City of Cottage Grove; and it is further

All legal notice for the public hearing to consider the matter of the surrender of these segments of Lincoln Avenue (County Road Numbers 1131) and South 10<sup>th</sup> Street (County Road Numbers 1163 and 1930) has been provided by the County Surveyor, as required by law.

The surrender of these segments of road will allow the city to have full jurisdiction of these roads and to maintain, develop, improve, and use these roads and the surrounding area to their own specifications, standards, and timetables. It is therefore recommended that the portion of Lincoln Avenue (County Road Number 1131) and South 10<sup>th</sup> Avenue, (County Road Numbers 1163 and 1930) as described in the Final Order, be surrendered to the City of Cottage Grove, as it will be in the best interest of the county.




