AGENDA ITEM TITLE: IN THE MATTER OF THE ALTERATION OF A PORTION OF PEARL

STREET (COUNTY ROAD NO. 254), LOCATED IN SECTION 33, TOWNSHIP 16 SOUTH, RANGE 3 WEST OF THE WILLAMETTE

MERIDIAN.

I. MOTION

In the Matter of the Alteration of a Portion of Pearl Street (County Road No. 254), Located in Section 33, Township 16 South, Range 3 West of the Willamette Meridian.

II. ISSUE

Right of way acquisition and improvements associated with reconstruction of Pearl Street (County Road No. 254) have been completed under the administration of the Lane County Department of Public Works. It is now necessary for the Board of Commissioners to decide whether the completed road project and its alignment should be legally altered as provided by ORS Chapter 368.

III. DISCUSSION

A. Background

County Road Number 254 was originally established in 1868, and was commonly known as VanDuyn Road. The portion of this road within the city limits of Coburg became known as Pearl Street, and in 1995 an Ordinance was approved by the Board of Commissioners to rename the entire portion west of I-5, Pearl Street. Pearl Street is a minor arterial road in the City of Coburg and is the connector route from the City of Coburg to the city's industrial zone and the I-5 freeway. The portion of the road to be altered begins at Coburg Road (County Road Number 2262, also known as Willamette Street) and extends easterly 0.56 miles, more or less, to Daray Street (County Road Number 2033). Although the subject portion of Pearl Street lies within the city limits of Coburg, since it is a County Road, the maintenance of the road is under the jurisdiction of Lane County.

Heavy truck traffic and increased traffic to the city's industrial area, inadequate storm drainage, and lack of pedestrian and bike facilities indicated a need for improvement for the safety of the traveling public in this area.

A Public Hearing was held on December 7, 1995 at Coburg Elementary School and on December 8, 1999 at the IOOF Hall in Coburg regarding the proposed road improvements. Through adoption of the Capital Improvement Programs for FY 1996-97 through FY 2003-04 and Resolution and Order No. 96-7-31-5 and No. 00-10-18-5 the Board of Commissioners, upon consideration of public testimony and recommendations, authorized the Lane County Department of Public Works to proceed with the design, preparation of construction plans, and acquisition of right of way of the portion of Pearl Street from Coburg Road, easterly, to Daray Street. Under the administration of the Lane County Department of Public Works and in coordination with the Coburg City Council and local transportation plans, the construction project has been completed.

B. Analysis

The report by the Director of the Department of Public Works, attached to the Order as Exhibit "B", notes that the alteration and construction of Pearl Street has been completed and the road is open for public travel. The final phase of the project is to complete the legal alteration of the road in accordance with ORS Chapter 368. The Order of Alteration accomplishes that action by providing for the acceptance of land acquired for right of way as a part of this project. The centerline description of the new alignment, including right of way widths, is attached to the Order as Exhibit "A."

The Lane County Public Works Department has filed road surveys numbered as CSF 36491 and CSF 38843 with the County Surveyor, which include road centerline and right of way monumentation in compliance with ORS Chapters 209.250 and 368.106.

C. Alternatives/Options

The Board of County Commissioners has the options to:

- 1. Approve the Order of Alteration of the portion of Pearl Street (County Road No. 254) from Coburg Road (Willamette Street) to Daray Street.
- 2. Have staff review and alter any component of the Order of Alteration for this portion of said Pearl Street.
- 3. Continue the motion for further consideration

D. Recommendations

It is recommended that the Board of Commissioners approve Option 1. This will approve the Order of Alteration of this portion of Pearl Street as proposed and supported by the Public Works Director.

E. Timing

Timing is important, as ORS 368.106 requires that the Order of Alteration and deeds or other documents establishing an interest in real property for public road purposes be recorded.

IV. IMPLEMENTATION/FOLLOW-UP

Upon approval by the Board of County Commissioners, the Order of Alteration and related attachments will be forwarded to the County Clerk for filing and entering into the Board of Commissioners' Journal of Administration. The Order of Alteration will be filed and indexed into the Road Index Books and legal County Road Files administered by the Department of Public Works and the County Surveyor.
