#### I. MOTION

MOVE TO APPOINT ONE MEMBER (Todd Johnston) TO THE LANE COUNTY

PLANNING COMMISSION.

#### II. ISSUE OR PROBLEM

There is a need to appoint one new member to serve on the Lane County Planning Commission due to the expiration of Marion Esty's 2<sup>nd</sup> term.

#### III. DISCUSSION

#### A. Background

Lane Code and Lane Manual provide that the Planning Commission shall be established and that the Lane County Planning Commission shall consist of nine voting members to perform the duties and functions of the Planning Commission. Also, at least one member shall be from the coastal area of Lane County, and another must be a resident or own property on the coast. There is currently one vacant position on the Lane County Planning Commission (not from the coastal area).

#### B. Analysis

County Administration advertised the vacancy in July & August, 2005 and received two applications in addition to nineteen others that had been kept on file to be considered for future vacancies. All applications received are attached.

The Board designated Commissioners Morrison and Stewart as a subcommittee to conduct interviews as provided by Lane Manual Section 3.506(2) (h). The recommendation of this subcommittee is for the new appointment of Todd Johnston.

Lane Manual and the ORS require that no more than two members of the Planning Commission be engaged in the buying, selling, or developing of real estate for profit as individuals, or be members of any partnership or officers or employees of any corporation that is engaged principally in the buying, selling or developing of real estate for profit. Also, no more than two voting members of the Planning Commission shall be engaged in the same kind of occupation.

Lane Manual requires the Lane County Planning Commission to consist of nine voting members, each of whom shall be a resident of Lane County, and at least three of the voting members shall reside outside cities and at least two shall reside within cities.

Of the eight remaining Lane County Planning Commission members, five (Kirkham, Carmichael, Arkin, Nichols, and Sullivan) reside outside city limits and three (Dignam, Becker, and Siekiel-Zdzienicki) reside inside city limits. The applicant, Todd Johnston, resides inside city limits. Composition of the planning commission, with the proposed appointment, would meet the Lane Manual residency and occupational requirements.

#### C. Alternatives/Options

- 1. Accept the subcommittee's recommendation to appoint Todd Johnston.
- 2. Appoint another applicant for this position.
- 3. Re-advertise and reopen the search for the vacancy.
- 4. Do not appoint a member to the Lane County Planning Commission.

#### D. Recommendations

Alternative 1 above.

#### E. Timing

Staff will follow-up the Board's recommendation immediately. Appointment and thank you letters are not included with this packet. The letters will follow pending the Board's decision.

- 1. I have lived and worked in Eugene for approximately ten years and, in that time, I have had the opportunity to work for two of the most prominent law firms in Eugene, Gleaves Swearingen Potter & Scott LLP and Hershner Hunter, LLP, representing a multitude of local and regional businesses, individuals and nonprofit organizations. My experience living in Lane County and working in the legal profession has provided me with opportunities to apply the analytical training that is necessary in sophisticated business practice to a multitude of local matters, including issues involving local land use and development, representing both businesses and individuals with dramatically varying objectives. I believe my ability to take a measured approach to difficult issues and utilize my analytical skills in a reasonable way, combined with my desire to participate in and contribute to the planning process in Lane County, will be of considerable value to the Committee.
- 2. The primary reasons I would like to be a member of this Committee include: an interest in participating in the local planning process, a desire to interact with and contribute to the community and to promote interest in local planning and zoning among younger members of the our community. 




