#### DEDICATION OF A PUBLIC ROAD EASEMENT

## James C. Archer and Diane C. Archer, Husband and Wife

GRANTORS, grant and dedicate to LANE COUNTY, a political subdivision of the State of Oregon (GRANTEE) a public road easement on and over the following described property:

A parcel of land lying in the Southwest one-quarter of the Northeast one-quarter (SW½ NE½) of Section 14, Township 18 South, Range 12 West of the Willamette Meridian, Lane County, Oregon, and being a portion of that tract of land conveyed to James C. Archer and Diane C. Archer, husband and wife as tenants by the entirety, by that statutory warranty deed recorded July 5, 2005, on Recorder's Reception Number 2005-049517, Lane County, Oregon Deed Records, included in a strip of land 30 feet in width lying on the northerly side of the centerline of Munsel Lake Road as surveyed by Lane County in 1994; the centerline being described as follows:

Beginning at Engineers' Centerline Station L<sup>2</sup> 24+93.43 PT, said station being 3816.24 feet North and 2032.94 feet West of the Brass Cap marking the Southeast Corner of Section 14, Township 18 South, Range 12 West of the Willamette Meridian, Lane County, Oregon; run thence South 77° 51' 18" East, 19.72 feet; thence along a 7639.44 foot radius curve right (the long chord of which bears South 76° 23' 20" East, 390.92 feet) a distance of 390.97 feet; thence South 74° 55' 22" East, 124.51 feet to Engineers' Centerline Station L<sup>2</sup> 30+28.63 PC and there ending, all in Lane County, Oregon.

The northerly line of the above described strip of land crosses GRANTOR'S westerly and easterly property lines opposite approximate Engineers' Centerline Stations L<sup>2</sup> 25+78 POC and L<sup>2</sup> 26+48 POC, respectively.

It being the intent herein to acquire right-of-way for Munsel Lake Road, County Road Number 1083. The parcel of land to which this description applies contains 0.01 of an acre, more or less, exclusive of existing right of way.

The description used herein is based upon a County Survey File No. 35975 through 35982, filed in the Office of the Lane County Surveyor. The bearings used herein are based on the Oregon Coordinate System of 1983, South Zone.

Said parcel being forever dedicated to the use of the public for road purposes and granting a public road easement. There is no consideration for this dedication.
