#### II. AGENDA ITEM SUMMARY:

Board approval is required to carry out the acquisition of the vacant site located at the SE corner of 8<sup>th</sup> Street and Laurel Street for the development of the New Winds Apartments, a proposed 18-unit apartment building in Florence.

#### III. BACKGROUND:

#### A. Introduction:

In May 2005, the Oregon Housing and Community Services Department (OHCS) issued a special Request for Applications (RFA) to develop an 18-unit apartment in Florence for adults with chronic mental illness. In this solicitation, OHCS offered a site, a preliminary design, and grants from its housing subsidy programs. HACSA

responded to the State's RFA and was notified in late July 2005 that its proposal had been received favorably. Project development is under way and it is time to acquire the site from the Oregon Housing and Community Services Department.

#### B. Analysis

Site Description

The site is a 19,440-square-foot, rectangular site, located on the southeast corner of 8<sup>th</sup> Street and Laurel Street. It is essentially level and is fully served by utilities. The site is zoned Multi-family Residential (RM) by the City of Florence. Schematic design indicates that it will accommodate the improvements anticipated for the New Winds Apartments.

In October 2005, HACSA obtained an appraisal of the site establishing the value at \$115,000. The appraised value has been used to establish the purchase price.

The location of this complex is well-suited for the proposed population (which almost always consists of single individuals without cars because it is within easy walking distance to many commercial and other services, as well as to support services offered by non-profit agencies.

**Financing** 

The cost of the site is reasonable and the acquisition of the site will be paid for within the range of subsidies that are available to this project.

#### C. Recommendation.

Approve the proposed Motion.

#### E. Timing.

Upon approval of the Order, the Executive Director will take the necessary actions to carry out the acquisition.
