AGENDA ITEM TITLE: IN THE MATTER OF THE ALTERATION OF A PORTION OF CEDAR

FLAT ROAD (COUNTY ROAD NUMBER 539) FROM HIGHWAY 126, SOUTHERLY, TO EAST CEDAR FLAT ROAD, LOCATED WITHIN SECTION 32, TOWNSHIP 17 SOUTH, RANGE 1 WEST OF THE

WILLAMETTE MERIDIAN.

I. MOTION

Move to Approve an Order Altering a Portion of Cedar Flat Road (County Road Number 539) from Highway 126, Southerly, to East Cedar Flat Road, Located within Section 32, Township 17 South, Range 1 West of the Willamette Meridian

II. ISSUE

Right of way acquisition and improvements associated with reconstruction have been completed on a portion of Cedar Flat Road (County Road Number 539), from Highway 126 (McKenzie Highway), southerly approximately 0.5 miles, to the intersection with East Cedar Flat Road. It is now necessary for the Board of Commissioners to decide whether the completed road project and its alignment should be legally altered.

III. DISCUSSION

A. Background

County Road Number 539 (commonly known as Cedar Flat Road) was originally established in 1904. Cedar Flat Road is a rural local road that stems off Highway 126, east of Springfield. The portion of the road to be altered is approximately 0.5 miles in length and extends southerly from its intersection with Highway 126, to the intersection with East Cedar Flat Road. The southerly portion of Cedar Flat Road, from milepost 0.5 to 2.2, was altered in 1988. The proposed alteration of the northerly segment will complete the formal modernization phase of Cedar Flat Road.

The road's poor pavement condition resulting from drainage problems and deficient road base indicated a need for improvement for the safety of the traveling public on this road.

A public meeting was held on January 14, 2004 at Walterville Elementary School to discuss the project and answer questions, and a Public Hearing was held on January 28, 2004 at the Lane County Public Works Operations Building. Upon consideration of public testimony and recommendations, and further, through Capital Improvement Programs from FY 2003-04 through FY 2007-08, and Board Order No. 04-5-19-10, the Board of Commissioners authorized the Lane County Department of Public Works to proceed with the right of way plans; pursue all necessary planning actions; acquire right of way and prepare plans and specifications for the improvement of the Cedar Flat Road Project.

B. Analysis

The Public Works Director's Report, attached to the Order as Exhibit "B", notes that the alteration and construction of Cedar Flat Road has been completed and the road is open for public travel. The final phase of the project is to complete the legal alteration of this road in accordance with ORS Chapter 368. The Order of Alteration accomplishes that action, including the acceptance of land acquired for right of way as a part of this project and vacates portions of the former right of way determined to be in excess. The centerline description of the new alignment including right of way widths is attached to the Order as Exhibit "A".

The Lane County Public Works Department has filed County Survey File No. 39847 with the County Surveyor, which includes road centerline and right of way monumentation in compliance with ORS Chapters 209.250 and 368.106.

C. <u>Alternatives/Options</u>

The Board of County Commissioners has the options to:

- 1. Approve the Order of Alteration of Cedar Flat Road from Highway 126 to the intersection with East Cedar Flat Road.
- 2. Have staff review and alter any component of the Order of Alteration of said portion of Cedar Flat Road, or
- Continue the motion for further consideration.

D. Recommendations

It is recommended that the Board of Commissioners approve Option 1. This will approve the Order of Alteration of this portion of Cedar Flat Road, as proposed and supported by the Public Works Director.

E. Timing

Timing is important, as ORS 368.106 requires that the Order of Alteration and deeds or other documents establishing an interest in real property for public road purposes be recorded.

IV. IMPLEMENTATION/FOLLOW-UP

Upon approval by the Board of County Commissioners, the Order of Alteration and related attachments will be forwarded to the County Clerk for filing and entering into the Board of Commissioners' Journal of Administration. The Order of Alteration and the road survey will be entered into the Road Index Books and County Road Files administered by the Department of Public Works and the County Surveyor for public record.

THIS MATTER now coming before the Board of County Commissioners for Lane County, Oregon, and the Board through adoption of the Capital Improvement Program for the Department of Public Works has determined that it was necessary to alter and reconstruct the portion of Cedar Flat Road that runs from the intersection with Highway 126 (McKenzie Highway), southerly approximately 0.5 miles, to its intersection with East Cedar Flat Road; and

WHEREAS, a public hearing was held on January 28, 2004 at the Lane County Public Works Operations Building regarding the proposed road improvements, and through adoption of the Capital Improvement Programs from FY 2003-04 through FY 2007-08, and Board Order No. 04-5-19-10, the Board of Commissioners authorized the Lane County Department of Public Works to proceed with the right of way plans; pursue all necessary planning actions; acquire right of way and prepare plans and specifications for the improvement of the Cedar Flat Road Project; and

WHEREAS, the Department of Public Works has completed the final road design and acquired all necessary right of way on and over which the project has been laid out; and

WHEREAS, the Public Works Department has completed the construction of the Cedar Flat Road project, in accordance with the plans and specifications prepared and administered by the Public Works Director; and

WHEREAS, it has been determined necessary to legally alter this portion of Cedar Flat Road, and accept the alignments including acquisitions made as a part of this project, as county road right of way; and

WHEREAS, the Department of Public Works has filed road survey numbered County Survey File 39847 with the County Surveyor for public record all in compliance with ORS 209.250 and 368.106; and

WHEREAS, the Board of County Commissioners is satisfied that necessary road construction and improvements have been completed and will be of public utility and benefit; now therefore, it is hereby

ORDERED that the deeds, or portions thereof, which lie within the road right of way specified herein, presented to the said Board of County Commissioners through purchase, donation, or agreement, as herein set forth below, on the dates set after the names of the Grantors, and before the recording information in the Lane County Deed Records, are hereby accepted as County road right of way:

The portion of the road to be altered is the most northerly segment extending from Highway 126 to East Cedar Flat Road, being approximately 0.5 miles in length. The southerly portion of Cedar Flat Road, from milepost 0.5 to milepost 2.2, was altered in 1988. The proposed alteration will complete the formal modernization phase of Cedar Flat Road.

The road's poor pavement condition resulting from drainage problems and deficient road base indicated a need for improvement for the safety of the traveling public.

A public meeting was held on January 14, 2004 at the Walterville Elementary School regarding the proposed road improvements and a Public Hearing was held on January 28, 2004 at the Lane County Operations Building. Upon consideration of public testimony and recommendations, and further through Capital Improvement Programs from FY 2003-04 through FY 2007-08, and Board Order No. 04-5-19-10, the Board of Commissioners authorized the Lane County Department of Public Works to proceed with the right of way plans; pursue all necessary planning actions; acquire right of way and prepare plans and specifications for the improvement of the Cedar Flat Road Project.

The Cedar Flat Road project construction plans were prepared and all necessary surveying, alignment design and mapping, additional right of way acquisition and reconstruction has been completed. All construction of this portion of road was completed in accordance with plans and specifications administered by the Department of Public Works.

An Order of Alteration to legally alter this portion of Cedar Flat Road has been prepared. The Order provides for acceptance of parcels of land and portions thereof acquired as right of way in conjunction with this project, and vacates portions of the former rights of way determined to be in excess. The legal description of the new alignment including right of way widths is marked Exhibit "A" and attached to the Order of Alteration.

The Department of Public Works has filed County Survey File No. 39847 with the County Surveyor, which include centerline and right of way monumentation in compliance with ORS Chapters 209.250 and 368.106.

The public interest will be served by the alteration of this road. It is therefore recommended that the Order of Alteration and related attachments be approved and that it be filed with the County Clerk and entered in the Board of Commissioners Journal of Administration. The Order of Alteration and the road surveys will then be entered into the Road Index Books and legal County Road Files administered by the Department of Public Works and the County Surveyor for public record.
