I. MOTION:

IT IS MOVED THAT RON KAUFMANN - BUILDER BE AWARDED A CONTRACT #06-C-0043 IN THE AMOUNT OF \$318,900.00 FOR LAURELWOOD RECONSTRUCTION: PHASE NINE AND THAT AN ORDER TO THIS EFFECT BE SIGNED; AND AN AGREEMENT BE EXECUTED IN ACCORDANCE WITH BID DOCUMENTS.

II. ISSUE

Board approval is required to award a contract for the Laurelwood Re-Construction: Phase Nine, located in Florence, Oregon .

III. DISCUSSION

A. Background:

The Agency is planning to accomplish comprehensive modernization of one duplex building (two 3 bedroom apartment units) in Florence, Oregon. This project is the ninth phase of modernization of the thirty Agency-owned apartment units at Laurelwood Homes, Florence, Oregon. The exterior work includes complete demolition followed by all new construction including walls, roof, windows, doors, vinyl siding, gutters and down spouts, drainage, concrete flat work, entries, underground utilities, fencing and additional site work. The interior work includes

new bath fixtures and vanities, bath fans, kitchen cabinets and counter tops, new plumbing and electrical work and new appliances, new wall structures, interior doors, closet doors, floor coverings, gyp-board and plaster wall texturing, paint, window coverings, heating system, and fire walls. The duplex building is located at 357/1359 11th Street, Florence.

B. Analysis

A formal bid process with a bid package was issued by the Agency for the required work. The project was advertised in several local papers and at the plan centers. Several contractors showed an interest in the project and were plan holders. One bid was obtained, and this bidder is responsive and responsible and they have reviewed their bid and confirmed their costs.

C. <u>Alternatives/Options</u>

In that the public bidding process was employed, the lowest bid has no irregularities the lowest total bid of \$318,900.00 has no irregularities and is responsive and responsible, and the prices are below our internal estimates, and are considered competitive, and there are sufficient budget funds to cover the project, we recommend award of the contract to Ron Kaufmann - Builder.

E. Timing

Upon bid award, the contractor shall have ten days to provide the Agency with a signed contract. It is anticipated that all other necessary documents could be processed by September 24, 2006 and work would commence shortly thereafter.
