WHEREAS, the Board of County Commissioners for Lane County, Oregon through the adoption of the Resolution, Notice of Hearing, and Order No. 06-8-2-5 has deemed that it may be necessary to legalize a portion of the road, now commonly known as Hulbert Lake Road; and

WHEREAS, Oregon Revised Statutes 368.201 provides for legalization of county roads where certain conditions exist which include, as in this case, determination that through conditions of omission or defect, doubt exists as to the legal establishment or evidence of establishment of a public road; and a county road that has been maintained by the county, used or traveled for 10 or more years, that does not conform to the location of the road described in the county road records or a defective road survey and the said Board being satisfied the legalization of the road, which is part of the traveled and maintained county road system, will be of public utility and benefit; and will enable improvements of the road by these proceedings; and

WHEREAS, the Board may deem it necessary and expedient and in the best interest of the public for Hulbert Lake Road to be legalized as a county road, with a variable width right of way; and

WHEREAS, legal notice is being provided by posting in accordance with ORS 373.270; and

WHEREAS, on September 13, 2006 at 1:30 P.M., at the Lane County Courthouse/Public Service Building, 125 East 8<sup>th</sup> Avenue, Eugene, Oregon, the Lane County Board of Commissioners will conduct a public hearing to formally consider the legalization of a portion of Hulbert Lake Road, County Road Number 160. [NOTE: If you are unable to attend the public hearing, you may write to the County Surveyor or Board of County Commissioners at the address noted below.];

NOW, THEREFORE, the Board of County Commissioners of Lane County may order as follows:




