II. AGENDA ITEM SUMMARY

An error in Resolution & Order 07-6-27-3 incorrectly listed Management Services as the Department for Funds 283 and 484. There was a change in the Department for those funds effective with the FY 2007-2008 budget and it should have been listed as Health & Human Services in the Order & Resolution.

III. BACKGROUND/IMPLICATIONS OF ACTION

A. Board Action and Other History

Board Order No. 07-5-9-5 moved the function of Animal Control from the Department of Management Services to the Department of Health & Human Services on May 9, 2007.

The Proposed Budget for FY 2007-2008 had already been prepared showing Animal Control as a division of Management Services, however, the Budget Committee was informed that the Division had moved to the Department of Health & Human Services and that the adjustment would be made in the budget software and reflected in budget adoption.

The use of a form from prior years contributed to the Resolution & Order mistakenly listing Management Services as the department for Funds 283 (Animal Regulation Authority Fund) and 484 (Animal Regulation Authority Capital Fund).

B. Policy Issues

The Adopted budget is in compliance with state budget law and do not conflict with any established County policy. This will not change with the proposed amendment.

C. Board Goals

Lane County's budget and financial management policies support the County's strategic goal of ensuring stability in service delivery to promote the efficient use of public funds.

D. <u>Financial and/or Resource Considerations</u>

None.

E. <u>Analysis</u>

Approving the amendment to the resolution & order will correct an inadvertent error, which if left uncorrected will cause confusion and possibly result in a budget violation.
