I. <u>MOTION</u>

Appoint Karen Bodner to the at-large position on the Roads Advisory Committee.

II. AGENDA ITEM SUMMARY

The Board is being asked to appoint Karen Bodner to the at-large position on the Roads Advisory Committee.

III. BACKGOUND/IMPLICATIONS OF ACTION

A. Board Action and Other History

One vacancy currently exists due to Richard "Pete" Maury's early retirement April 2007, leaving a remaining term to be filled that ends June 30, 2009.

Committee Bylaws stipulate that each Commissioner appoint a representative from their district, plus two at-large positions. The current vacancy is one of the at-large positions resulting from the retirement of Richard "Pete" Maury in April 2007.

Three applications were received by the Roads Advisory Committee. After an interview panel of three members, the panel and remaining three committee members have provided a unanimous recommendation for Karen Bodner to be appointed.

B. Policy Issues

The Board has provided direction wanting to standardize committee structure so each is made of five members and Two, at-large members appointed by the full board. The Roads Advisory Committee is already operating under this structure.

C. Board Goals

The Roads Advisory Committee supports Lane County's Strategic plan of providing citizen participation and community development.

D. Financial and/or Resource Considerations - N/A

E. Analysis

Karen brings extensive knowledge from serving eight years on the Vegetation Management Advisory Committee through December 2006. Additionally, Karen is very familiar with Public Works functions.

F. Alternative Options

- 1. Appoint Karen Bodner to this remaining term through June 2009.
- 2. Do not appoint Karen Bodner and consider other two candidates.
- 3. Not appoint Karen Bodner or the other candidates, and re-advertise the vacancy.

V. TIMING/IMPLENTATION

Action today will allow appointee to participate in August Roads Advisory Functions.

VI. RECOMMENDATION

The Committee recommends Karen Bodner be appointed to the at-large position.
