### I. MOTION

Order/\_\_\_\_\_ In The Matter Of Appointing. Designees Of The  
Community Mental Health Director To Direct A Peace Officer To Take A Mentally Ill  
Individual Into Custody According To ORS 426.233.

### II. ISSUE OR PROBLEM

In accordance with ORS 426.233, the Community Mental Health Director must recommend and the Board of County Commissioners must approve Director's designees allowed to direct peace officers to take into custody a person who the Director or his designee has probable cause to believe is in need of immediate care, custody or treatment for mental illness. This approval is valid for the term of employment or until recommended by the Community Mental Health Director and approved by the Board of County Commissioners to remove the designation.

The list of appointed designees was updated on March 14, 2007. Since that date the Mental Health Director has approved five additional people and request that they be added to this list. In addition, this order will remove from the list any designees who no longer need this designation.

To approve the additions and deletions to the list of Director's designees as presented.

WHEREAS, Lane County regards community safety as a high priority, and

WHEREAS, the 1997 Legislative Assembly amended ORS 426.233 to permit the local Community Mental Health Director or his/her designees to direct a peace officer to take an allegedly mentally ill individual into custody; and

WHEREAS, a designee must be recommended by the Community Mental Health Director and be approved by the county governing body; and

WHEREAS, Board Order 07-03-14-03 appointed designees to perform that function and since the last Board Order, personnel changes at Lane County Mental Health require that an updated list of designees be appointed.

NOW, THEREFORE, IT IS HEREBY ORDERED that the Lane County Board of Commissioners authorize the updated list of Community Mental Health Director's designees operating under ORS 426.233 to direct peace officers to take into custody a person who the Director or his designee has probable cause to believe is in need of immediate care, custody or treatment for mental illness. This approval is valid for the term of employment or until recommended by the Community Mental Health Director and approved by the Board of County Commissioners to remove the designation. Any previously appointed persons not on this updated list are removed as designees.
