I. MOTION

IN THE MATTER OF APPOINTING ONE MEMBER TO THE PUBLIC SAFETY COORDINATING COUNCIL (PSCC).

II. ISSUE OR PROBLEM

Shall the Board of Commissioners appoint Robert Lehner, Eugene Police Chief, to the Public Safety Coordinating Council?

III. DISCUSSION

A. Background

The Public Safety Coordinating Council, by statute and intergovernmental agreement, is charged with:

- Developing a plan to serve the adult and youth offender population with state and local resources;
- Coordinating local adult and juvenile criminal justice policy;
- Making recommendations to improve the criminal justice system.

Membership of the PSCC is established by State statute (ORS 423.560) with additional members identified in Lane Manual (LM 3.522).

One of the statutory positions is a chief of police selected by the chiefs of police of the county. Chief Jerry Smith of Springfield has served for several years. On 1/16/07 the chiefs met and agreed to have Chief Robert Lehner of Eugene serve in this capacity.

B. Alternatives/Options

1. Adopt the Order, ratifying the appointment of Robert Lehner to the PSCC.
2. Reject the Order and do not ratify the recommended PSCC appointment at this time.

C. Recommendations

Adopt the Order, ratifying the appointment of the designated appointee. The new member will begin formal participation in PSCC activities upon adoption of the Order.
