IN THE MATTER OF THE ALTERATION OF THE PORTION OF NORTH GAME FARM ROAD (PORTIONS OF COUNTY ROADS NO. 1043, 42, 209, AND 975) FROM COBURG ROAD, SOUTHEASTERLY, TO THE CITY LIMITS OF EUGENE, LOCATED WITHIN SECTIONS 9, 15 AND 16, TOWNSHIP 17 SOUTH, RANGE 3 WEST OF THE WILLAMETTE MERIDIAN.

## I. MOTION

In the Matter of the Alteration of the Portion of North Game Farm Road (Portions of County Roads No. 1043, 42, 209, and 975) from Coburg Road, Southeasterly, to the City Limits of Eugene, located within Sections 9, 15 and 16, Township 17 South, Range 3 West of the Willamette Meridian.

#### II. AGENDA ITEM SUMMARY

Right of way acquisition and improvements associated with reconstruction have been completed by the Lane County Department of Public Works on North Game Farm Road. It is now necessary for the Lane County Board of Commissioners to decide whether the completed road project and its alignment should be legally altered.

# III. BACKGROUND/IMPLICATIONS OF ACTION

## A. Board Action and Other History

North Game Farm Road, as it is commonly known, being portions of County Road Number 42, established in 1894; County Road Number 1043, established in 1928 and designated as Market Road Number 41; a portion of County Road Number 209 that was relocated in 1958; and a portion of County Road Number 975, established in 1924 and known as Armitage Road. North Game Farm Road is an urban major collector that runs along the east edge of the Urban Growth Boundary of Eugene. The road runs from Coburg Road, southeasterly, approximately 6800 feet to a point where it crosses under Interstate 5 and becomes Gateway Street. North Game Farm Road serves as a connection between Springfield and Eugene, Springfield and Coburg, and serves as a local connection to 1-5 via Beltline Road. The segment of North Game Farm Road proposed to be altered is the portion from Coburg Road to the Eugene city limits, approximately 1000 feet west of the

centerline of Interstate 5. The intersection with Arand 975) is also included in this project.

A small segment of the right of way lies within the cand the City of Eugene entered into an Intergovernmy whereby the City authorized Lane County to make in assess properties within the limits of the city; and

County 260(1) way, and

Lack of pedestrian and bike facilities, narrow roadway, and an increase of traffic volume due to new development indicated a need for improvement for the safety of the traveling public in this area. The improvements include two travel lanes and a continuous center turn lane, bike lanes, and sidewalks along the portions that are within the city limits.

A public informational meeting regarding the proposed road improvements was held on July 9, 2003 followed by a public hearing on July 23, 2003 at the Lane County Public Works Building. Upon consideration of public testimony and recommendations, and further, through the adoption of Capital Improvement Programs from FY 2003-04 through FY 2007-08, and Board Order No. 03-10-29-1, No. 05-2-16-7, and No. 05-3-30-10, the Board of Commissioners authorized the Lane County Department of Public Works to proceed with the right of way plans; pursue all necessary planning actions; acquire right of way and prepare plans and specifications for the improvement of the North Game Farm Road Project. Under the administration of the Lane County Department of Public Works, the construction project has been completed.

#### B. Policy Issues

The initiation and acquisition of property and construction was authorized by the adoption of Capital Improvement Programs from FY 2003-04 through FY 2007-08, and Board Order No. 03-10-29-1, No. 05-2-16-7, and No. 05-3-30-10, for the North Game Farm Road Project.

A few areas of the subject right of way lie within the city limits of Eugene, and portions of this right of way have been previously dedicated to the City of Eugene. On December 14, 2004, Lane County and the City of Eugene entered into an Intergovernmental Agreement per ORS 373.260(1) whereby the City authorized Lane County to make improvements, acquire right of way, and assess properties within the corporate limits of city. When the project is complete the areas dedicated to the city will be incorporated in the county road right of way.

This project appears to be consistent with Oregon Revised Statute 368, which allows for the initiation and acquisition of property, and Lane Code Chapter 15, which provides for improvement, development or redevelopment of County Roads in accordance with the Comprehensive Plan.

#### C. Board Goals

#### **GOALS**

#### Lane County's Goals

Lane County Government exists to ensure the safety and well being of the people who live, work and visit our communities. That includes personal safety, security of property, preservation of infrastructure, health safety, and assisting in providing for our citizens' basic needs. One such goal is to protect the public's assets by maintaining, replacing or upgrading the County's investments in systems and capital infrastructure. (GOALS, LANE COUNTY STRATEGIC PLAN 2001-2005, Page 13.)

## D. Financial and/or Resource Considerations

The acquisition of property and the construction of portions of N. Game Farm Road have been completed. Therefore, no additional cost will be incurred as a result of completing the legal alteration of the roads.

#### E. Analysis

Construction of the altered portion of North Game Farm Road, from Coburg Road to the city limits of Eugene, has been completed and is open for public travel. The road has been improved to conform to urban standards along the westerly side, within the Urban Growth Boundary, and meets rural standards along the easterly side, which is outside of the Urban Growth Boundary.

The final phase of the project is to complete the legal alteration of the road in accordance with ORS Chapter 368. The Order of Alteration accomplishes that action, including the acceptance of land acquired for right of way as a part of this project and vacates portions of the former right of way determined to be in excess. The centerline description of the new alignments including right of way widths is attached to the Order of Alteration as Exhibit "A".

The Lane County Public Works Department has filed a road survey numbered 39848 with the County Surveyor, which includes road centerline and right of way monumentation in compliance with ORS Chapters 209.250 and 368.106.

#### F. Alternatives/Options

The Board of County Commissioners has the options to:

- 1. Approve the Order altering the portion of North Game Farm Road, from Coburg Road to the city limits of Eugene.
- 2. Have staff review and alter any component of the Order altering the aforementioned portion of North Game Farm Road.
- 3. Continue the motion for further consideration.

#### V. TIMING/IMPLEMENTATION

Timing is important, as ORS 368.106 requires that the Order of Alteration and deeds or other documents establishing an interest in real property for public road purposes be recorded.

# VI. RECOMMENDATION

It is recommended that the Board of Commissioners approve Option 1. This will approve the Order altering this portion of North Game Farm Road as proposed and supported by the Public Works Director.

#### VII. FOLLOW-UP

Upon approval by the Board of County Commissioners, the Order of Alteration and related attachments will be forwarded to the Lane County Clerk for filing and entering into the Board of Commissioners' Journal of Administration. The Order will be filed and indexed into the Road Index Books and legal County Road Files administered by the Department of Public Works and the County Surveyor.

THIS MATTER now coming before the Board of County Commissioners for Lane County, Oregon, and the Board through adoption of the Capital Improvement Program for the Department of Public Works has determined that it was necessary to alter and reconstruct the portion of North Game Farm Road that runs from Coburg Road to the City of Eugene city limits, said road consisting of portions of County Road Numbers 1043, 42, 209 and Market Road Number 41, and also including the intersection at Armitage Road, County Road Numbers 42 and 957; and

WHEREAS, a public meeting was held on July 9, 2003 and a public hearing on July 23, 2003 at Lane County Public Works Building regarding the proposed road improvements, and through adoption of the Capital Improvement Programs from FY 2003-04 through FY 2007-08, and Board Order No. 03-10-29-1, No. 05-2-16-7, and No. 05-3-30-10, the Board of Commissioners authorized the Lane County Department of Public Works to proceed with the right of way plans; pursue all necessary planning actions; acquire right of way and prepare plans and specifications for the improvement of the North Game Farm Road Project; and

WHEREAS, a small segment of the right of way lies within the city limits of Eugene, and Lane County and the City of Eugene entered into an Intergovernmental Agreement per ORS 373.260(1) whereby the City authorized Lane County to make improvements, acquire right of way, and assess properties within the limits of the city; and

WHEREAS, the Department of Public Works has completed the final road design and acquired all necessary right of way on and over which the project has been laid out; and

WHEREAS, the Public Works Department has completed the construction of the North Game Farm Road project, in accordance with the plans and specifications prepared and administered by the Public Works Director; and

WHEREAS, North Game Farm Road runs along the Urban Growth Boundary (UGB), and the road has been improved to conform to urban standards along the west side, within the UGB, and to rural standards along the east side, outside of the UGB; and

WHEREAS, it has been determined necessary to legally alter this portion of North Game Farm Road, and accept the alignments including acquisitions made as a part of this project, as county road right of way; and

WHEREAS, the Department of Public Works has filed County Survey File 39848 with the County Surveyor for public record all in compliance with ORS 209.250 and 368.106; and

WHEREAS, the Board of County Commissioners is satisfied that necessary road construction and improvements have been completed and will be of public utility and benefit; now therefore, it is hereby

**ORDERED** that the deeds, or portions thereof, which lie within the road right of way specified herein, presented to the said Board of County Commissioners through purchase, donation, or agreement, as herein set forth below, on the dates set after the names of the Grantors, and before the recording information in the Lane County Deed Records, are hereby accepted as County road right of way:

ORDERED, that all portions of County Roads Number 1043, 42, 209, 975, and Market Road Number 41 lying between the termini specified herein above which are not included within the limits of the road herein above described are HEREBY DECLARED VACATED in accordance with ORS 368.126, EXCEPT NOT VACATING and retaining all that portion of Coburg Road and North Game Farm Road that was included in the Alteration of Coburg Road, Order Number 04-9-1-14, and ALSO NOT VACATING any portion of North Game Farm Road that has been surrendered to the City of Eugene, by Order Number 91-2-13-15, and retaining unto any and all existing public utilities the right to preserve, maintain, repair, replace, remove or reinstall any public utility that may now exist within the bounds of the portions of County Roads Number 1043, 42, 209, 975, and Market Road Number 41 herein described by these proceedings as vacated; and it is further

Upon consideration of public testimony and recommendations, and further, through the adoption of Capital Improvement Programs from FY 2003-04 through FY 2007-08, and Board Order No. 03-10-29-1, No. 05-2-16-7, and No. 05-3-30-10, the Board of Commissioners authorized the Lane County Department of Public Works to proceed with the right of way plans; pursue all necessary planning actions; acquire right of way and prepare plans and specifications for the improvement of the North Game Farm Road Project.

The North Game Farm Road project construction plans were prepared and all necessary surveying, alignment design and mapping, additional right of way acquisition and reconstruction has been completed. All construction of this portion of road was completed in accordance with plans and specifications administered by the Department of Public Works. The newly constructed road includes two travel lanes and a continuous center turn lane, bike lanes, and sidewalks along the portions that are within the city limits.

An Order of Alteration to legally alter this portion of North Game Farm Road has been prepared. The Order provides for acceptance of parcels of land and portions thereof acquired as right of way in conjunction with this project, and vacates portions of the former right of way determined to be in excess. The legal description of the new alignment including right of way widths is marked Exhibit "A" and attached to the Order of Alteration.

The Department of Public Works has filed County Survey File Number 39848 with the County Surveyor,

which includes centerline and right of way monumentation in compliance with ORS Chapters 209.250 and 368.106.

The public interest will be served by the alteration of this road. It is therefore recommended that the Order of Alteration and related attachments be approved and that it be filed with the County Clerk and entered in the Board of Commissioners Journal of Administration. The Order of Alteration and the road survey will then be entered into the Road Index Books and legal County Road Files administered by the Department of Public Works and the County Surveyor for public record.
