AGENDA ITEM TITLE: ORDER/IN THE MATTER OF ENTERING INTO A RECIPROCAL STRIPING AGREEMENT WITH THE OREGON DEPARTMENT OF TRANSPORTATION (ODOT) IN THE NOT-TO-EXCEED AMOUNT OF \$300,000 PER YEAR (REVENUE) AND \$10,000 PER YEAR (EXPENSE) FOR THREE YEARS

I. **MOTION**

THAT THE BOARD ORDER BE APPROVED AUTHORIZING A RECIPROCAL STRIPING AGREEMENT WITH THE OREGON DEPARTMENT OF TRANSPORTATION (ODOT) IN THE NOT-TO-EXCEED AMOUNT OF \$300,000 PER YEAR (REVENUE) AND \$10,000 PER YEAR (EXPENSE) FOR A PERIOD OF THREE YEARS AND AUTHORIZING THE COUNTY ADMINISTRATOR TO EXECUTE THE AGREEMENT.

II. **DISCUSSION**

A. **Background / Analysis**

Under the authority of Chapter II, Section 8 of the Lane County Home Rule Charter and ORS Chapter 190, it is the policy of Lane County to offer services to other public agencies where feasible. ODOT and Lane County have determined it is mutually beneficial and to the general public's benefit if ODOT and County resources are jointly utilized.

Under the terms of the proposed agreement, Lane County would provide striping services to ODOT on the state highway system on a reimbursement basis. ODOT would provide striping services to the County on the County road system on a reimbursement basis as needed. Services and equipment would be provided upon mutually convenient times and locations depending upon the County's availability to provide services.

B. Recommendation

It is hereby recommended the board order be approved authorizing entering into a reciprocal striping agreement with ODOT on a reimbursement basis and also authorizing the County Administrator to execute the agreement.

ORDERED, that the reciprocal striping agreement with the Oregon Department of Transportation (ODOT) is authorized in the not-to-exceed amount of \$300,000 per year (revenue) and \$10,000 per year (expense) for a period of three years and the County Administrator is authorized to execute the agreement.
