COMMITTEE CHARGE:

To advise the Board of County Commissioners and Human Services Commission (HSC) on services that alleviate the conditions of poverty and promote and improve the health, well-being, self-sufficiency, and safety of low income, disadvantaged, and disabled Lane County residents. The committee reviews the annual budgets, plans, and evaluations of the operation of human services sponsored by the HSC to insure program effectiveness.

D. BACKGROUND / ANALYSIS:

The Lane County Board of County Commissioners has served as the governing board for Lane County's Community Action Program since 1972. The Community Action Program is the delivery system for state and federal anti-poverty programs. Since 1983 the operation of this mandated advisory committee, for anti-poverty funding in Lane County, has functioned to assist the HSC as a part of its budget and planning process. This coupling of functions has allowed for the efficient integration of decision-making in the allocation of funding to local non-profit groups.

This committee has designated slots for recruitment within the mandated tripartite advisory board structure, consisting of equal parts local private sector, public sector, and low income representatives. The HSC designated slots for recruitment for specific community interests include: clergy, criminal justice programs, health care organizations, consumers, public welfare programs, and advocacy organizations. This structure brings together community leaders from each of these groups to collaborate on developing responses to local needs.

At the September 13, 2006 BCC meeting, the HSC had requested that Eugene City Councilor Andrea Ortiz be appointed to a first one-year term given elected public officials are appointed to serve on the HSC on a one year basis. A one-year waiver to the LM 3.530 4-year term requirement was granted on the basis that the Department of Health and Human Services would come back with a proposal for an amendment to the Lane Manual.

Given that since the last Board appointment action (06-9-13-13), the Human Services Commission in discussion with the Department of Health and Human Services, has been reviewing options for consolidating this committee with the Human Services Commission we have not come back to the Board with a LM revision request. Further discussion and action on the consolidation proposal will occur this fall. Therefore, at this time, to comply with state and federal statutory requirements -- to have a majority of the advisory committee appointed -- we are requesting the BCC waive the LM 3.530 requirement for 4 year terms and make these appointments for one-year.

Four of the seven recommended appointees are continuing there service on the committee for an additional one-year term. The other three appointees are new to the committee. None of the new appointments that are being recommended are filling midterm vacancies. Therefore the one-year appointment terms being requested do not conflict with LM 3.506(2) (g) in regard to filling mid-term vacancies.

The Community Action Advisory Committee approved the recommendation of the new appointments and reappointments at their June 11 meeting.

- 1. Experience Please find attached a resume. Included in my 34 years as an educator was working as an At-Risk Counselor at South Eugene High School for 13 years. I was also in charge of substance abuse prevention and intervention. The past 2 years I have worked at Community Rehabilitation Services of Oregon. We provide medical rehabilitation services and vocational placement of persons with brain injury, AD/HD, and other disabilities. I have also worked with several non-profits by placing persons with disabilities in volunteer positions and supervising the clients ability to become competitively employable. I am also co-owner of this business (please see attached pamphlet). I have 4 grown children. Three were adopted when they were 4, 6, and 8 years old. One is a mechanical engineer for a prestigious firm, one works in a sheltered work setting and is mentally ill and the other struggles with addiction. I say this because our family has been personally involved with state and federal aid. I have experienced emotionally what cannot be fully understood intellectually.
- 2. Contribution As an educator, vocational counselor, business person and parent I have done considerable networking in the Human Services community. I am acutely aware of the budget crisis the state faces and the challenges this brings to social services and its constituents. Distributing limited funds is really a values clarification process. I want to see data that shows what programs are most effective in our county. I want to be able to compare them to successful programs in other areas. I hope that I can help the committee work creatively to find solutions. I have little tolerance for inequity or inefficiency. I can ask hard questions and make hard decisions. I am able to focus on the big picture and what is best for the long run.
- 3. Community Concerns That our limited resources are doing the most good for the most people. That decisions can be made that have long term impact. That decisions are made with the best information that can be attained. That all people are treated with dignity and respect.
- 4. Community Involvement I was on the Downtown Rotary Committee that developed a Memorandum of Understanding to deal with substance abuse problems in our community. It resulted in a matrix used by Youth Services, Eugene Police Department, and schools for consistent communication and consequences related to substance abuse violations. I was on a committee to establish a Youth Center in Eugene. I was on the Youth Action Committee for Lane Educational Services District. Our business has just become a member of the Chamber of Commerce. I am a long time member of Central Presbyterian Church, served as deacon and have been actively involved in this socially conscious community. I have worked on 3 Habitat for Humanity Houses.
- 5. **Diversity** Our immediate family is racially diverse. Two of our children are of Latino heritage and one is Asian. I helped start the Hispanic Club at South Eugene High School. I also organized an educational evening event that brought together all of the minority clubs. I sought out funds and resources for low income students. I work with people with disabilities and am very familiar with the American Disabilities Act. I helped develop a week long curriculum for the prevention of AIDS which was gender neutral. I am deeply committed to preventing all types of discrimination.
