II. **DISCUSSION**

A. Background/Analysis

City of Eugene and Lane County entered into a 3-year Intergovernmental Agreement (IGA) 2008-02901 for Adult Work Crew Services.

County wishes to provide work activities for its inmates, and the City of Eugene wishes to accomplish certain maintenance work on City owned land.

Cost adjustments for work crew services are determined at the beginning of each budget cycle.

The original IGA required 36 work crew spaces from 1 July-31 December 2007 and 24 work crew spaces from 1 January-30 June 2008 for a total cost of \$95,313 with work performed on Fridays, Saturdays and Sundays.

Amendment No. 1 increases the work crew spaces to 36 from 1 January-3 February 2008, and to 48 from 4 February-30 June 2008 with work to be performed on Mondays, Tuesdays, Fridays, Saturdays and Sundays for a total cost of \$130,312.74.

Lane Manual 21.147(4) requires Board of Commissioner approval for execution of an amendment when combined with the original contract amount totals over \$100,000.

B. <u>RECOMMENDATION</u>

Staff recommends approving execution of Amendment No. 1 to Intergovernmental Agreement 2008-02901 between City of Eugene and Lane County for Adult Work Crew Services.

The IGA benefits both governmental agencies.

INTERGOVERNMENTAL AGREEMENT Adult Work Crew Services

BETWEEN: The City of Eugene, a Municipal

This Amendment is made to the Inter-Governmental Agreement (Non-Facility) Contract dated 07/01/2007, between the City of Eugene (City) and Lane County (Contractor) for Adult Work Crew Services.

AGREEMENT

City and Contractor mutually agree to amend the contract referenced above as follows:

1. Paragraph 1.2 is amended to provide:

County agrees to provide thirty-six (36) work crew spaces from July 1, 2007 to February 3, 2008 and 48 work crew spaces from February 4, 2008 to June 30, 2008.

2. Paragraph 3.2 is amended to provide:

The work will be performed on Mondays, Tuesdays, Thursdays, Fridays, Saturdays and Sundays.

Paragraph 5 is amended to provide:

Consideration. The consideration which City shall pay to County, for both the work performed by the County and the expenses incurred by County in performing the work, shall not exceed \$130,312.74 for FY08 based on the schedule of rates described in the attached Exhibit B. City shall make payments, based on quarterly invoices from County. City's payment shall be made within 30 days after receipt of County's statement. County shall not be entitled to reimbursement for travel or other expenses unless specified on the attached schedule of rates.
