II. ISSUE OR PROBLEM

In order for Lane County to bill Medicare and Medicaid for covered mental health and physical health services provided by Lane County staff, applications must be submitted.

III. DISCUSSION

A. Background/Analysis:

Board Order 04-02-11-06 delegated authority to the County Administrator, William VanVactor, as an authorized representative to sign applications to Medicare and Medicaid. As William VanVactor is no longer the County Administrator, a new order must be approved delegating authority to the County Administrator, Jeff Spartz, as an authorized representative to sign applications to Medicare and Medicaid.

Medicare and Medicaid billings have been an ongoing source of funding for mental and physical health services.

B. Alternative/Options

1. To delegate authority to the County Administrator as an authorized

representative to sign applications to Medicare and Medicaid related to mental and physical health services

2. Not to delegate authority to the County Administrator as an authorized representative to sign applications to Medicare and Medicaid related to mental and physical health services

C. Recommendation

Upon approval by the Board, Medicare and Medicaid applications will be routed to the County Administrator for approval.
