I. MOTION

Order and Resolution/In the Matter of Approving a Modification to the 2007-09 Lane County Community Corrections Plan and Increasing Appropriations in FY 2007-08 by \$100,000 for Parole & Probation Services in the Department of Health & Human Services.

II. <u>DISCUSSION</u>

A. Background / Analysis

The 2007-09 Lane County Community Corrections Plan was approved by the board on June 27, 2007 (board order 07-6-27-3). The budget submitted with that plan had \$862,554 designated as "Other Services." Included in that category was \$716,554 of "Unallocated" funding. During the spring months of 2008 work was done to determine the best use of those funds and a recommendation was made to the Lane County Public Safety Coordinating Council (PSCC) on May 15, 2008. The PSCC reviewed the recommendation to move \$351,277 in fiscal year 2007-08 and \$365,277 in fiscal year 2008-09 into programs in the Department of Health & Human Services (H&HS) and the Department of Public Safety. The funding recommendation is summarized below:

The Department of Public Safety has included the 2007-08 funding recommended for their department in Supplemental III. However, the \$100,000 for Community Supervision (Parole & Probation) in this fiscal year must be appropriated through this board order. Next fiscal year, Parole & Probation will be housed in the Department of Public Safety (DPS). DPS has assumed the responsibility for budget action in regard to the 2008-09 fiscal year.

The state requires the county to submit a Plan Modification form when funds are reallocated among program categories. Evidence of BCC approval is not needed at the state; however, this information is brought to the board from the PSCC with a recommendation to accept the revision.

B. <u>Recommendation</u>

To approve the motion stated above. The Modification to the <u>2007-09 Lane County Community Corrections Plan</u> has been forwarded from the Public Safety Coordinating Council per action taken at the May 15, 2008 meeting of that body.

In addition, the Department of Health & Human Services requests appropriation of \$100,000 to support Parole & Probation services in the 2007-08 fiscal year.

WHEREAS, Lane County submitted the Plan that had \$716,554 of the funding unallocated to specific programs; and,

WHEREAS, the Lane County Public Safety Coordinating Council met on May 15, 2008 and agreed to forward a proposal recommending transfer of the unallocated funds to enhance program services in the Department of Public Safety and for Parole & Probation (Department of Health & Human Services) funded in the plan; and,

WHEREAS, the state Department of Corrections requires receipt of a Plan Modification whenever funds are reallocated among the Plan's program categories; and,

WHEREAS, appropriation of funds for the Department of Public Safety will be done through Supplemental III to the budget for the 2007-08 fiscal year; and

WHEREAS, \$100,000 recommended to support Parole & Probation Services in the Department of Health & Human Services for the 2007-08 fiscal year must be appropriated;

NOW THEREFORE, IT IS HEREBY ORDERED, that the Board of County Commissioners approve the *Plan Modification* to the <u>2007-09 Lane County Community Corrections Plan</u>; and,

IT IS HEREBY RESOLVED AND ORDERED, that the Board of County Commissioners appropriates an additional \$100,000 in revenues and expenses to support Parole & Probation Program services in Heath & Human Services Fund 286 in the Department of Health & Human Services.
