II. AGENDA ITEM SUMMARY

The current contract for Inmate Telephone Services at the Lane County Adult Corrections Facility expires February 2008. A Request for Proposal was prepared and advertised in order to competitively select a new vendor. The process is complete, the proposal should be accepted and a contract executed.

III. BACKGROUND/IMPLICATIONS OF ACTION

A. **Board Action and Other History**

Lane County's primary interests are in providing a telephone system that offers reliable service at the lowest reasonable cost to the users of the telephone system. Rates charged are to be comparable to or lower than those currently charged by the dominant carriers in this area.

There is no charge to Lane County for the inmate or public telephone services. The provider of the telephone service is responsible for the installation and maintenance of equipment, line fees and billing/collection fees.

An invitation to submit Proposals for the Inmate Telephone Services for Lane County Corrections Facilities was prepared and advertised online at the Lane County internet website and the Sheriff's Office, Corrections Division internet website beginning 8 January 2008.

In response to the Request for Proposal, seven proposals were received, as listed on the proposal recap sheet.

B. Policy Issues

Per Lane Manual 21.107(5), depending upon the authority to execute a contract per LM 21.145, the recommendation for award of the contract shall be considered and finally decided by either the Board or the County Administrator.

Per Lane Manual 21.145, contracts exceeding \$100,000 and/or 3 years in length require board approval.

C. Board Goals

Relevant strategic plan goals are:

Revenue Development – Lane County Government supports generating revenue for the general fund while providing a service to the inmates and their families.

D. Financial and/or Resource Considerations

FSH Communications will pay Lane County an effective rate of 50% commission on gross revenue. It is estimated the annual revenue for telephone service will be \$200,000.

E. Analysis

All proposals were evaluated by Lane County Adult Corrections staff and the Lane County interim purchasing manager for conformance to request for proposal specifications and requirements.

The proposal submitted by FSH Communications was determined to best meet the request for proposal specifications.

Evaluation criteria placed emphasis on proposer qualification; technical requirements; system features and options; installation maintenance; rates, billing and commissions and cultural competency.

The contract will be a three-year revenue contract with an estimated value of \$600,000.

F. <u>Alternatives/Options</u>

Option 1. Adopt the order to award a three-year revenue contract to FSH Communications and authorize its execution.

Option 2. Do not approve the order to award the contract and thereby not provide telephone services to Lane County inmates and not receive the benefit of additional revenue.

V. TIMING/IMPLEMENTATION

Upon approval by the Board, Sheriff's Office will proceed with contract processing.

D. RECOMMENDATION

Staff recommends option 1.

Contracting inmate telephone services has proven to provide a service to the inmates and their families while also generating additional revenue for the general fund.

III. FOLLOW-UP

Following Board action, a contract will be executed between FSH Communications and Lane County.
